Surveyor's Description of 2.048 Acre Parcel

The following described parcel of land is a part of the Southeast Quarter of Section 1, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box (found) located at the Northeast corner of the Southeast Quarter of said Section 1, Wayne Township, same being on the County Line between Auglaize and Hardin Counties;

Thence with a bearing of S. $89^{\circ}-41'-10"$ W. along the centerline of McGinnis Road (Township Road #196), for a distance of 811.48 feet to a Monument Box (found) located at the intersection of Mertz Joint Road (County Road #137A) with said McGinnis Road;

Thence with a bearing of S. 21°-06'-13" E. along the centerline of Mertz Joint Road (County Road #137A) for a distance of 105.00 feet to a Mag Nail (set) and the PLACE OF BEGINNING;

Thence continuing with a bearing of S. 21°-06'-13" E. along the centerline of Mertz Joint Road (County Road #137A) for a distance of 449.00 feet to a Mag Nail (set);

Thence with a bearing of S. 89°-26'-23" W. for a distance of 262.44 feet to an Iron Pin (set), and passing thru an Iron Pin (set) for reference at a distance of 22.00 feet;

Thence with a bearing of N. 09°-13'-30" W. for a distance of 234.15 feet to an Iron Pin (set);

Thence with a bearing of N. 04°-24'-52" W. for a distance of 190.06 feet to an Iron Pin (set);

Thence with a bearing of N. 89°-41'-10" E. for a distance of 152.93 feet to a Mag Nail (set), and passing thru an Iron Pin (set) for reference at a distance of 130.93 feet, said Mag Nail (set) being the original PLACE OF BEGINNING.

Containing in all 2.048 Acres of land, of which, 0.309 Acre being previously dedicated for highway purposes. The above described tract of land is also subject to any or all legal easements, reservations, or restrictions, if any, upon said premises. The basis of bearings used for this survey were determined from the Global Positioning Survey of the Auglaize County Engineer where the centerline of Mertz Joint Road (C.R. 307A) has a bearing of S. 21°-06′-13″ E.

The creation of the above described 2.048 Acre Parcel is being split from a former 50.44 Acre Parcel of land referenced by permanent parcel #N41-001-007-00. Previous Deed Reference: Deed Volume 224, Page 714, Auglaize County Recorder's Office.
