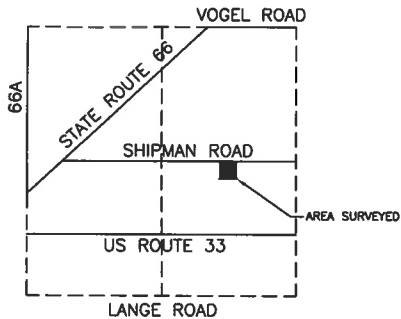
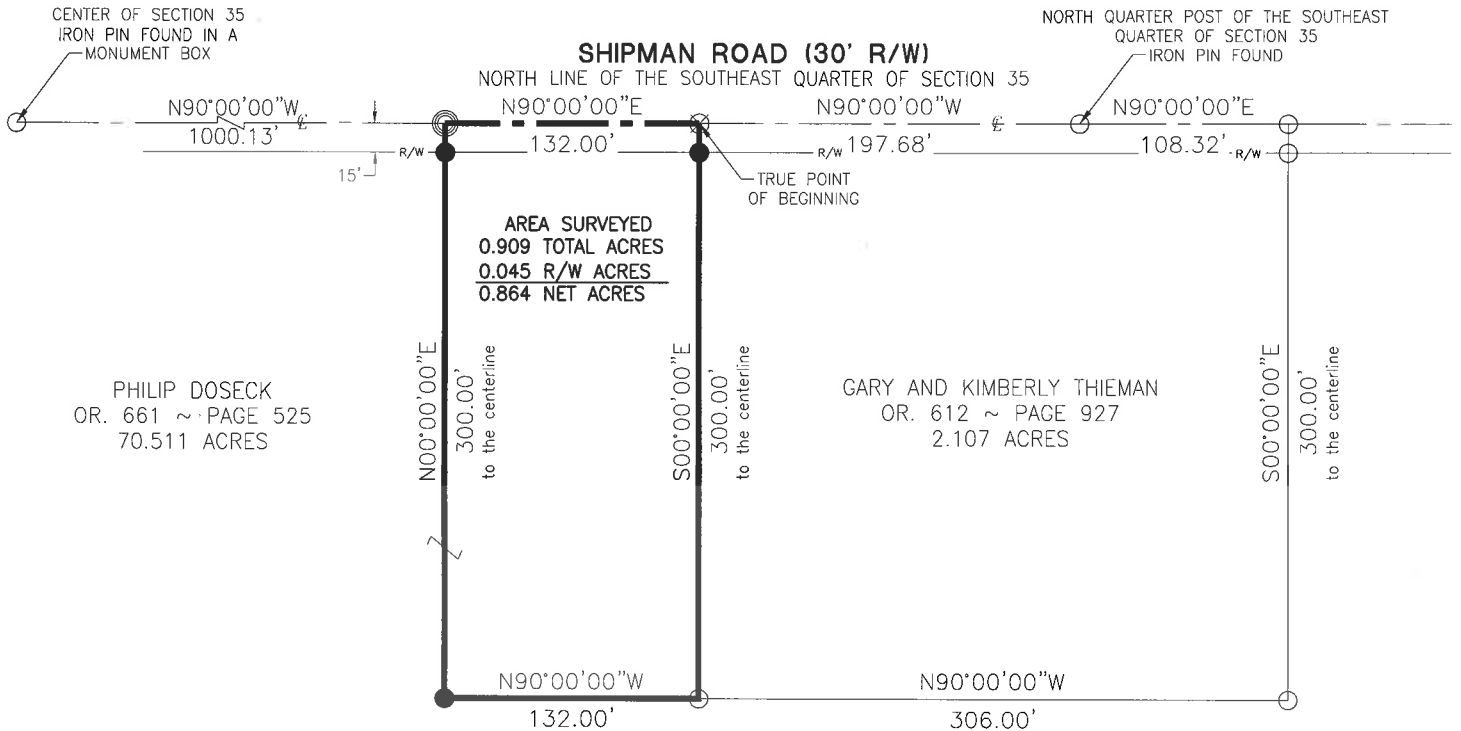

0.909 Acres**

Being part of Parcel #H2303500800 of the North Half of the Southeast Quarter of Section 35, Town 5 South, Range 4 East, Noble Township, Auglaize County, Ohio, and described as follows:

Commencing at an Iron Pin Found marking the North Quarter Post of the Southeast Quarter of said Section 35;

Thence North 90°00'00" West along the North line of the Southeast Quarter of Section 35 and the approximate centerline of Shipman Road, a distance of one hundred ninety-seven and sixty-eight hundredths feet (197.68') to a Mag Nail Found, marking the **TRUE POINT OF BEGINNING**;

Thence South 00°00'00" East along the West line of a tract as recorded in Official Record 612 Page 927, a distance of three hundred and zero hundredths feet (300.00') to an Iron Pin Found, passing an Iron Pin Set at fifteen and zero hundredths feet (15.00');

Thence North 90°00'00" West a distance of one hundred thirty-two and zero hundredths feet (132.00') to an Iron Pin Set;

Thence North 00°00'00" East a distance of three hundred and zero hundredths feet (300.00') to a Mag Nail Set, passing an Iron Pin Set at two hundred eighty-five and zero hundredths feet (285.00');

Thence North 90°00'00" East along the North line of Southeast Quarter of Section 35 and the approximate centerline of Shipman Road, a distance of one hundred thirty-two and zero hundredths feet (132.00') to the **TRUE POINT OF BEGINNING**, containing 0.909 acres of land more or less, of which 0.045 acres is road right of way.
