



Description for Mark D. Dahlinghaus 11.000 Acres

Being part of a 68.048 Acre tract, located in the Southeast Quarter of the Northeast Quarter of Section 19, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, and described as follows:

Commencing at an Iron Pin in a Monument Box Found marking the Southeast corner of the Northeast Quarter of said Section 19;

Thence North 00°00'00" East along the East line of the Northeast Quarter of said Section 19 and the approximate centerline of Waynesfield Road, a distance of nine hundred eighty-nine and zero hundredths feet (989.00') to a Mag Nail Set, marking the **TRUE POINT OF BEGINNING**;

Thence North 89°56'37" West along the North line of a tract as recorded in O.R. 620 Page 840, a distance of two hundred fifty-nine and fifty-seven hundredths feet (259.57') to an Iron Pin Found, passing an Iron Pin Found at 24.84';

Thence North 00°00'00" East a distance of nineteen and fifty-four hundredths feet (19.54') to an Iron Pin Set;

Thence South 89°25'14" West a distance of one thousand three hundred fifty-eight and zero hundredths feet (1358.00') to an Iron Pin Set;

Thence North 00°04'51" West a distance of three hundred three and ninety-seven hundredths feet (303.97') to an Iron Pin Found;

Thence North 89°25'14" East along the North line of the Southeast Quarter of the Northeast Quarter, a distance of one thousand four hundred ninety-nine and twenty-nine hundredths feet (1499.29') to an Iron Pin Set;

Thence South 20°11'25" East along the West line of Lot #158 of the Atkinson Addition, a distance of two hundred fifty-seven and four hundredths feet (257.04') to an Iron Pin Set;

Thence South 90°00'00" East along the South line of Lot #158 of Atkinson Addition, a distance of thirty and zero hundredths feet (30.00') to a Mag Nail Set;

Thence South 00°00'00" West along the East line of the Northeast Quarter of said Section 19 and the approximate centerline of Waynesfield Road, a distance of eighty-three and ninety-four hundredths feet (83.94') to the **TRUE POINT OF BEGINNING**, containing **11.000 Acres** of land more or less.

Said tract being subject to all highways and any other easements or restrictions of record.
