## **SURVEYOR'S AFFIDAVIT**

I, James M. Kent, PS 6792, being a Professional Surveyor, registered to practice in the State of Ohio, do hereby make the following assertion.

(Please note the following corrections are bold & italicized)

Being a part of Tract One, Parcel Five of the West Central Ohio Industrial Park, situate in the *northwest* quarter of Section 4, Town-6-South, Range-6-East, Pusheta Township, City of Wapakoneta, Auglaize County, Ohio as evidenced by Official Record Volume *688*, Page *1123* and part of Parcel No. I4504500500 and more particularly described as follows:

Commencing for reference at a 5/8" re-rod w/cap (found) at the intersection of the west line of Section 4 and the south right-of-way line of Commerce Drive; thence, S 88° 53' 43" E along the aforesaid right-of-way line for a distance of 644.65 feet to a 5/8" re-rod w/cap (found) and the **POINT OF BEGINNING** for the parcel herein described;

Thence, continuing along the aforesaid right-of-way line, S 88° 53' 43" E for a distance of 552.96 feet to a 5/8" re-rod w/cap (fount);

Thence, S 00° 55' 13" W for a distance of 675.53 feet to a 5/8" re-rod w/cap (found);

Thence N 88° 52' 53" W for a distance of 554.12 feet to a 5/8" re-rod w/cap (found);

Thence, N 01° 01' 10" E for a distance of 675.39 feet to the **POINT OF BEGINNING**, containing therein 8.583 acres. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per the Record Plat of West Central Ohio Industrial Park.
