Being a part of a parcel of land situated in the Northwest Quarter of Section 35, Township 4 South, Range 6 East, formerly Duchouquet Township, now in the Village of Cridersville, Auglaize County, Ohio, acquired by James A. Loescher in instruments recorded in Official Record 244 Page 80 and Official Record 662, Page 2376, of the Auglaize County, Ohio, deed records and being more particularly described as follows:

BEGINNING FOR THE SAME at a PVC fence post found marking the northwest corner of Lot 2 in Graham Addition (Plat Book A, Page 45) -

Thence South 01°-35'-28" West on and along said Loescher and the west line of said Lot 2 for a distance of 15.61 feet to a point, witnessed by a 5/8-inch iron rebar capped with a marker stamped "Jauret PS 6920" found North 65°-03'-17" West at 0.41 feet -

Thence South 89°-43'-31" West on and along the south line of said Loescher for a distance of 208.19 feet to a 5/8-inch iron rebar set -

Thence North 01°-00'-20" East through said Loescher lands on the proposed division line for a distance of 174.87 feet to a 5/8-inch iron rebar set on the north line of said Loescher -

Thence North 89°-43'-31" East (Basis of Bearings – taken from O.R.244, P.80) on and along the north line of said Loescher for a distance of 217.48 feet to 5/8-inch iron rebar capped with a marker stamped "Jauret PS 6920" found -

Thence South 01°-35'-28" West on and along the east line of said Loescher and the west line of Lots 4 and 3 in said Graham Addition for a distance of 159.39 feet to a bent 5/8-inch iron rebar found under a telephone/fiber optic pedestal on the north line of said Lot 2 -

Thence North 89°-38'-27" West on and along said Loescher and the north line of said Lot 2 for a distance of 7.50 feet to the place of beginning.

Being a part of a parcel of land situated in the Northwest Quarter of Section 35, Township 4 South, Range 6 East, formerly Duchouquet Township, now in the Village of Cridersville, Auglaize County, Ohio, acquired by James A. Loescher in instruments recorded in Official Record 244 Page 80 and Official Record 662, Page 2376, of the Auglaize County, Ohio, deed records and being more particularly described as follows:

COMMENCING FOR REFERENCE at a PVC fence post found marking the northwest corner of Lot 2 in Graham Addition (Plat Book A, Page 45) -

Thence South 01°-35'-28" West on and along said Loescher and the west line of said Lot 2 for a distance of 15.61 feet to a point, witnessed by a 5/8-inch iron rebar capped with a marker stamped "Jauret PS 6920" found North 65°-03'-17" West at 0.41 feet -

Thence South 89°-43'-31" West on and along the south line of said Loescher for a distance of 208.19 feet to a 5/8-inch iron rebar set marking the **PRINICIPAL POINT OF BEGINNING** for the parcel to be described by this instrument -

Thence continuing South 89°-43'-31" West on and along the south line of said Loescher for a distance of 20.00 feet to a point, witnessed by a 5/8-inch iron rebar capped with a marker stamped "Jauret PS 6920" found North 06°-56'-40" West at 0.30 feet -

Thence North 03°-17'-43" East on and along the west line of Loescher and passing through an existing house of an adjoiner built circa 2016 for a distance of 175.16 feet to a 5/8-inch iron rebar set (set over an uncapped bent 5/8-inch rebar found 1.1' below grade) marking the northwest corner of said Loescher -

Thence North 89°-43'-31" East (Basis of Bearings – taken from O.R.244, P.80) on and along the north line of said Loescher for a distance of 13.00 feet to 5/8-inch iron rebar set –

Thence South 01°-00'-20" West through said Loescher lands on the proposed division line for a distance of 174.87 feet to the place of beginning.
