

## Parcel "A" LEGAL DESCRIPTION


Being a part of Parcel #I45-005-011-00 (Prior Deed Referenced in O.R. 605, Pg. 148) and being a part of the N½ of the NE¼ of Section 5, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio, more particularly described as follows:

Commencing at an existing 1" Iron Pin at the NE corner of Section 5; thence N 89°-40'-30" W with the N line of the NE  $\frac{1}{4}$  of Section 5, 678.34' to a #5 Rebar set on the southerly right-of-way of State Route 33; thence S 01°-12'-58" W, 654.78' to an existing 6" Wood Post at the POINT OF BEGINNING, passing an existing  $\frac{1}{4}$ " Iron Pipe at 2.35'; thence the following courses:

- 1. S  $01^{\circ}$ -12'-58'' W, 702.66' to an existing #5 Rebar on the S line of the N ½ of the NE ¼ of Section 5;
- 2. N 89°-36'-24" W with said fractional section line, 1893.84' to a point on the centerline of County Road 25-A, as referenced by an existing Cotton Gin Spindle at (0.31' E), passing a set #5 Rebar at 1843.61';
- 3. N 05°-04'-45" W with the centerline of County Road 25-A, 703.10' to a set Mag Spike;
- 4. \$89°-41'-06" E, 1970.99' to the POINT OF BEGINNING, passing a set #5 Rebar at 50.25'.

The above described parcel contains 31.109 acres, more or less, of which 0.807 acres are occupied by road right-of-way, subject to all legal highways and easements of record.

## Parcel "B" LEGAL DESCRIPTION



Commencing at an existing 1" Iron Pin at the NE corner of Section 5; thence S 89°-47'-57" E with the N line of the NW ¼ of Section 4, 1314.02' to an existing Mag Nail at the NE corner of the W ½ of the NW ¼ of Section 4; thence S 00°-41'-19" W with said fractional section line, 657.21' to a #5 Rebar set at the POINT OF BEGINNING; thence the following courses:

- 1. Continuing S 00°-41'-19" W with the E line of the W ½ of the NW ¼ of Section 4, 699.21' to a #5 Rebar set on the S line of the N ½ of the NW ¼ of Section 4;
- 2. N 89°-52'-23" W with said fractional section line, 1316.48' to a #5 Rebar set at the SW corner of the N ½ of the W ½ of the NW ¼ of Section 4;
- 3. N 89°-36'-24" W with the S line of the N ½ of the NE ¼ of Section 5, 688.41' to an existing #5 Rebar;
- 4. N 01°-12′-58" E, 702.66' to an existing 6" Wood Post, passing an existing #5 Rebar at 692.66';
- 5. \$89°-41'-06" E, 1998.38' to the POINT OF BEGINNING.

Beginning at an existing 1" Iron Pin at the NE corner of Section 5; thence the following courses:

- 1. S 89°-47'-57" E with the N line of Section 4, 1314.02' to an existing Mag Nail at the NE corner of the W ½ of the NW ¼ of Section 4;
- 2. S 00°-41'-19" W with said fractional section line, 657.21' to a set #5 Rebar;
- 3. N 89°-41'-06" W, 1998.38' to an existing 6" Wood Post;
- 4. N 01°-12'-58" E, 654.78' to a #5 Rebar set on the N line of Section 5, passing an existing ½" Iron Pipe at 652.43';
- 5. \$89°-40'-30" E with said fractional section line, 678.34' to the POINT OF BEGINNING.

The above described parcel contains 30.025 acres, more or less, of which 1.615 acres are occupied by road right-of-way, subject to all legal highways and easements of record.
