SITUATE IN THE SOUTHWEST QUARTER OF SECTION 12 TOWN 5S RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY RICHARD & DORTHY KRITES AS RECORDED IN OFFICIAL RECORD 647 PAGE 46 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a 1 inch iron pin found in Auglaize County Engineer's Office box at the northwest corner of the northwest quarter of the southwest quarter of Section 12 and being in the intersection of the centerlines of County Road 66-A and Bloody Bridge Road, said iron pin marking the **Point of Beginning** of the tract herein described;

Thence, with the centerline of Bloody Bridge Road, South 01°53'00" West, 248.67 feet to a Mag Nail in shiner found;

Thence, with the centerline of Bloody Bridge Road along a curve to the left having a Delta Angle of 53°15'26", Radius of 220.37 feet, Arc Length of 204.84 feet with a Long Chord Bearing South 24°45'04" East for 197.54 feet to the P.T. of said curve passing for reference at 202.40 feet a Mag Nail with shiner found;

Thence, with the centerline of Bloody Bridge Road, South 51°33'55" East, 193.29 feet to a Mag Nail set, crossing the centerline of State Route 66 at 80.00 feet;

Thence, with the west line of the Miami & Erie Canal lands, South 38°20'45" West, 649.24 feet to an iron pin set, passing for reference at 88.27 feet an iron pin set in the south right of way line of Bloody Bridge Road;

Thence, with the west line of the Miami & Erie Canal lands, North 51°30'08" West, 49.00 feet to an iron pin set, passing at 35.00 feet the east right of way line of State Route 66;

Thence, continuing with the west line of the Miami & Erie Canal lands, South 39°23'12" West, 442.95 feet to a point in the center of Brewer Ditch, passing for reference at 392.95 feet to an iron pin set;

Thence, with the general centerline of Brewer Ditch the following 11 courses:

Roby as recorded in Official Record 139 Page 739, North 01°10'57" East, 420.80 feet to a Mag Nail set in the centerline of County Road 66-A, passing for reference at 30.00 feet an iron pin set and at 378.41 feet an iron pin set in the south right of way line of County Road 66-A;

Thence, with the centerline of County Road 66-A, North 46°13'30" East, 533.28 feet to a Mag Nail set;

Thence, with a curve to the right having a Delta Angle of 44°20'02", Radius of 286.39 feet, Arc Length of 221.60 feet with a Long Chord Bearing North 68°23'31" East for 216.11 feet to a Mag Nail set in the north line of the southwest quarter of Section 12;

Thence, with the north line of the southwest quarter of Section 12 and the centerline of County Road 66-A, South 89°26'28" East, 754.60 feet to the **Point of Beginning** containing 33.774 acres more of less of which 5.494 lie within the rights of way of State Route 66, County Road 66-A and Bloody Bridge Road and being subject to all legal rights of way, easements, agreements and restrictions of record..
