LEGAL DESCRIPTION

Being Parcel #D12-027-001-00 and being a part of the SE ¼ of Section 27, being a part of Parcel #D12-026-002-00 and being a part of the SW ¼ of Section 26, & being a part of Parcel #D12-035-001-00 and being a part of the NW ¼ of Section 35, Town 5 South, Range 8 East, Goshen Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 660, Pg. 400), more particularly described as follows:

Beginning at an existing Monument Box at the NW corner of the SE ¼ of Section 27; thence the following courses:

- 1. \$ 89°-59'-27" E with the N line of the SE ¼ of Section 27 (centerline of May Road), 1297.55' to an existing Monument Box at the NW corner of the E ½ of the SE ¼ of Section 27 (centerline intersection of May Road and Heitt Road);
- 2. S 89°-56′-03" E continuing with said fractional section line, 1320.85' to an existing Monument Box at the NE corner of the SE ¼ of Section 27;
- 3. S 00°-51'-52" E, 1322.02' to a set #5 Rebar;
- 4. S 89°-27'-31" E, 1294.65' to a #5 Rebar set on the E line of the W ½ of the SW ¼ of Section 26;
- 5. S 01°-07'-14" W with said fractional section line, 1327.21' to a #5 Rebar set at the SE corner of the W ½ of the SW ¼ of Section 26;
- 6. S 00°-52'-43" W with the E line of the W $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 35, 657.26' to a set #5 Rebar;
- 7. N 89°-58'-01" W, 1324.74' to a #5 Rebar set on the W line of the NW ¼ of Section 35:
- 8. N 00°-43'-29" E with said fractional section line, 657.26' to a #5 Rebar set at the SE corner of Section 27;
- 9. N 89°-53'-40" W with the S line of the SE ¼ of Section 27, 709.50' to a set #5 Rebar;
- 10. N 01°-02'-16" E, 1329.93' to a #5 Rebar set on the S line of the N ½ of the SE ¼ of Section 27;
- 11. N 89°-55′-41" W with said fractional section line, 1931.30' to a Mag Nail set at the SW corner of the N ½ of the SE ¼ of Section 27, passing a set #5 Rebar at 1911.30';
- 12. N 01°-33′-45" E with the W line of the SE ¼ of Section 27, 1329.05' to the POINT OF BEGINNING.

The above described parcel contains 163.061 acres, more or less, of which 41.285 acres are located in Section 26, 101.776 acres are located in Section 27, 20.000 acres are located in Section 35, and 1.803 acres are occupied by road right-of-way, subject to all legal highways and easements of record.

The system of bearings for this legal description is based on the Ohio State Plane-North Coordinate System NAD83 (2011).
