




Commencing at a Monument Box (found) at the Northeast corner of the Northeast Quarter of Section 2, Logan Township and in the centerline of Township Road 200 (Monroe Road);

Thence N.89°24'29"W. along the centerline of Township Road 200 and the North line of the Northeast Quarter of said Section 2, a distance of 439.68 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°35'31"W. a distance of 405.06 feet to an iron pin (set), passing thru an iron pin (set) at 20.00 feet in the South right-of-way line of Township Road 200;

Thence N.89°24'29"W., parallel to the centerline of Township Road 200 and the North line of the Northeast Quarter of said Section 2, a distance of 334.17 feet to a Cotton Gin Spindle (found), passing thru an iron pin (found) at 300.92 feet in the Easterly right-of-way line of State Route 198;
