THENCE, NORTH 01°-23'-28" EAST, 318.86 FEET, ALONG THE EAST LINE OF SAID VILLAGE OF MINSTER TRACT TO AN IRON PIN WITH CAP SET ON A SOUTHERLY LINE OF SAID VILLAGE OF MINSTER TRACT;

THENCE, SOUTH 89°-11'-57" EAST, 183.69 FEET, ALONG THE SOUTHERLY LINE OF SAID VILLAGE OF MINSTER TRACT TO AN IRON PIN WITH CAP SET;

THENCE, SOUTH 01'-23'-28" WEST, 318.91 FEET, ALONG A NEW DIVISION LINE TO AN IRON PIN WITH CAP SET ON THE NORTH LINE OF SAID LOT 5;

THENCE, NORTH 89'-10'-57" WEST, 183.69 FEET, ALONG THE NORTH LINE OF LOT 5 TO THE PLACE OF BEGINNING.
