



LEGAL DESCRIPTION

Being Parcel #M39-007-004-00 (Prior Deed Referenced in O.R. 677, Pg. 772) and being located in the NE ¼ of Section 30, Town 6 South, Range 5 East and being a part of Lots #3 & 4 of the Werheim Addtion (P.B. A, Pg. 94) to the Village of New Knoxville, Auglaize County, Ohio, more particularly described as follows:

Beginning at a #5 Rebar set at the NW corner of said Lot #3; thence the following courses:

- 1. N 89°-04'-37" E with the northerly line of Lot #3, 90.24' to a set #5 Rebar;
- 2. S 00°-00'-25" W, 79.58' to a set #5 Rebar;
- 3. S 89°-28'-14" W, 90.14' to a #5 Rebar set on the westerly line of said Lot #3;
- 4. N 00°-03'-28" W, with the westerly line of said Lot #3, 78.96' to the POINT OF BEGINNING.

The above described parcel contains 0.164 acres, more or less, subject to all legal highways and easements of record.

The system of bearings for this legal description is based on the Ohio State Plane-North Coordinate System NAD83 (2011).
