


LOCATION PLAN




Jackson Township, T-7-S, R-4-E, Auglaize County, Ohio.

KEN SOMMER SURVEY 3.197 ACRE TRACT

The following described tract of land is part of the West half of the Southeast Quarter of Section 29, Town 7 South, Range 4 East, Jackson Township, Auglaize County, Ohio, being part of Parcel No. E14-029-010-02 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Southwest corner of the Southeast Quarter of Section 29, Jackson Township and in the intersection of the centerlines of Township Road 25 (Sommers Road) and County Road 30 (Minster-Ft. Recovery Road);

Thence N.01°44'09"E. along the centerline of Township Road 25 and the West line of the Southeast Quarter of said Section 29, a distance of 2,231.61 feet to a R.R. Spike (found) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.01°44'09"E. along the above described line, a distance of 434.43 feet to an iron pin (set) at the center of Section 29, Jackson Township;

Thence S.88°39'37"E., along the North line of the Southeast Quarter of said Section 29, a distance of 320.01 feet to an iron pin (set);

Thence S.01°44'09"W., parallel to the centerline of Township Road 25 and the West line of the Southeast Quarter of said Section 29, a distance of 435.85 feet to an iron pin (found);

Thence N.88°24'01"W. a distance of 320.00 feet to the R.R. Spike (found), passing thru an iron pin (found) for reference at 308.00 feet, said R.R. Spike was the true PLACE OF BEGINNING.

Containing in all 3.197 Acres of which 0.150 Acre has been used for highway purposes and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 652, Page 545. This plat is recorded in Survey Book "T", Page 409, in the Auglaize County Engineer's Office. Basis for bearings for this tract is holding the centerline of Township Road 25 and the West line of the Southeast Quarter of Section 29, Jackson Township as N.01°44'09"E. from the Ohio State Plane-North Coordinate System NAD83 (2011).
