SITUATE IN THE SOUTHEAST QUARTER OF SECTION 21 AND THE SOUTHWEST QUARTER OF SECTION 22 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY ROBERT H. WILKER, RONALD M. WILKER & MARILYN R. POHLMAN (CO-TRUSTEES) AS RECORDED IN OFFICIAL RECORD 439 PAGE 1752 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Commencing at a 1 inch iron pin found in a Auglaize County Engineer's Office box at the northeast corner of the southeast quarter of Section 21 and being in the centerline of Dowty Road;

Thence, with the east line of the southeast quarter of said Section 21 and the west line of a 12.977 acre tract of land owned by Dry Feeder Farms, LLC as recorded in Official Record 614, Page 741, South 00°54'48" West, 660.34 feet, said point marking the **True Point of Beginning** of the tract herein described, witnessing at North 55°59'51" West, 0.62 feet to an iron pin found with Geeslin cap;

Thence, continuing with the east line of the southeast quarter of said Section 21 and the west line of said 12.977 acre tract, South 00°54'48" West, 66.03 feet, witnessing at South 00°54'48" West, 0.52 feet to an iron pin found with Geeslin cap;

Thence, with the south line of said 12.977 acre tract, South 88°23'30" East, 217.22 feet to an iron pin set;

Thence, with the west line of a 1.519 acre tract of land owned by Eugene and Cynthia Wilker as recorded in Official Record 256, Page 961, South 02°03'45" West, 395.15 feet to a Mag Nail set, passing for reference at 359.75 feet an iron pin set in the north right of way line of County Road 66A;

Thence, with the centerline of County Road 66A, South 60°00'32" West, 206.41 feet to a Mag Nail set;

Thence, continuing with the centerline of County Road 66A, South 45°51'32" West, 142.50 feet to a Mag Nail set, passing for reference at 45.54 feet the east line of the southeast quarter of Section 21;

Thence, with a new division line, North 87°58'40" West, 602.42 feet, to an iron pin found, passing for reference at 41.59 feet an iron pin set in the north right of way line of County Road 66A;

Thence, with the east line of a 90 acre tract of land owned by Cedardowns Farm LLC as recorded in Official Record 686, Page 559, North 01°04'11" East, 658.95 feet to wooden fence post;

Thence, with the south line of 18.047 acre tract of land owned by Karl and Denise Dammeyer as recorded in Official Record 449, Page 2310, South 89°05'15" East, 669.00 feet to the **True Point of Beginning** containing 12.425 acres more of less of which 0.259 acre lie within the rights of way of County Road 66-A, 10.179 acre being in the southeast quarter of Section 21 and 2.246 acres being in the southwest quarter of Section 22 an being subject to all legal rights of way, easements, agreements and restrictions of record..

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
