Commencing at a monument box marking the southeast corner of the northeast quarter of Section 13 also being the centerline of Holden Line Road:

thence S 89° 15' 18" W, a distance of 656.50 feet to a ½ inch iron pin (found) passing at 20.00 feet a ½ inch iron pin (found) at the POINT OF BEGINNING for the parcel to be described;

thence continuing S 89° 15' 18" W, a distance of 656.50 feet to a ½ inch iron pin (found);

thence N 00° 02' 07" W, a distance of 2,642.09 feet to a ½ inch iron pin (found); thence N 89° 12' 12" E, a distance of 1,314.65 feet to a monument box (found) marking the northeast corner of the northeast quarter of Section 13, passing at 1,294.65 feet a ½ inch iron pin (found);

thence with the centerline of Holden Line Road, S 00° 00' 00" W, a distance of 1,981.72 feet to a PK nail (found);

thence with a new division line S 89° 15' 18" W, a distance of 656.50 feet to a 5/8 inch iron pin (set) passing at 20.00 feet a ½ inch iron pin (found);

thence S 00° 00' 00" W, a distance of 661.58 feet to the POINT OF BEGINNING containing 69.730 acres, more or less, subject to all legal highways and easements of record. thence with a new division line N 00° 00′ 00″ E, a distance of 661.58 feet to a 5/8 inch iron pin (set);

thence N 89° 15′ 18″ E, a distance of 656.50 feet to a PK nail (found) in the centerline of Holden Line Road passing at 636.50 feet a ½ inch iron pin (found);
