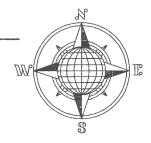

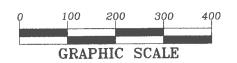

## AARON HOUSER SURVEY 14.803 ACRE TRACT

The following described tract of land is part of the West half of the Southwest Quarter of Section 27, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, being part of Parcel No. F19-027-005-01 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Southwest corner of the Southwest Quarter of Section 27, Logan Township and in the intersection of the centerlines of County Road 210 (National Road) and County Road 101 (Conant Road);

Thence N.00°41'15"E. along the centerline of County Road 101 and the West line of the Southwest Quarter of said Section 27, a distance of 372.00 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.00°41'15"E. along the above described line, a distance of 953.40 feet to a Mag Nail (set);

Thence S.89°10'14"E., along the North line of the South half of the Southwest Quarter of said Section 27, a distance of 676.39 feet to an iron pin (set), passing thru a 6-inch dia. Steel Post (found);

Thence S.00°41'15"W., parallel to the centerline of County Road 101 and the West line of the Southwest Quarter of said Section 27, a distance of 953.36 feet to an iron pin (set);

Thence N.89°10'26"W. a distance of 676.39 feet to the Mag Nail (set), passing thru an iron pin (set) for reference at 646.39 feet in the East Right-of-Way line of County Road 101, said Mag Nail was the true PLACE OF BEGINNING.

Containing in all 14.803 Acres of which 0.547 Acre has been used for highway purposes and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 560, Page 1243. This plat is recorded in Survey Book "T", Page 489, in the Auglaize County Engineer's Office. Basis for bearings for this tract is holding the centerline of County Road 101 and the West line of the Southwest Quarter of Section 27, Logan Township as N.00°41'15"E. from the Ohio State Plane-North Coordinate System NAD83 (2011).
