

## HUGH CORE SURVEY

Part of the Southeast Quarter of Section 25, Town 4 South, Range 4 East, Salem Township, Auglaize County, Ohio.





## HUGH CORE DESCRIPTION 3.572 ACRE

Commencing at a Stone (found) at the Southeast corner of the Southeast Quarter of Section 25, Salem Township;

Thence N.03°06'10"E. along the East line of the Southeast Quarter of Section 25, a distance of 223.47 feet to a Monument Box (found) in the centerline of County Road 210 (National Road);

Thence N.79°17'10"W. along the tangent centerline of County Road 210, a distance of 1,337.79 feet to a P.K. Nail (found) on the East line of the West half of the Southeast Quarter of Section 25, Salem Township;

Thence continuing N.79°17'10"W. along the tangent centerline of County Road 210, a distance of 8.31 feet to a R.R. Spike (found) at the P.I.;

Thence N.88°56'50"W., along the tangent centerline of County Road 210, a distance of 349.38 feet to a Mag Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.88°56'50"W. along the centerline of County Road 210, a distance of 300.86 feet to a R.R. Spike (found) in the intersection of State Route 197;

Thence N.19°33'00"W. along the centerline of State Route 197, a distance of 319.56 feet to a P.K. Nail (found);

Thence N.62°27'37"E. a distance of 413.51 feet to an iron pin (found), passing thru an iron pin (found) at 30.29 feet in the East right-of-way line of State Route 197;
