Being a part of Parcel Number H23-008-00-302 and part of Parcel Number H23-008-00-304, both parcels being a part of a 14.029 acre parcel of land conveyed to Danny and Kathy Mullins by deed recorded at Official Record 639, page 1809, in Noble Township, Auglaize County, Ohio, in the south half of the southeast quarter of Section 8, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the southeast corner of said Section 8 -

Thence, North 00°12'45" West, along the east line of the southeast quarter of said Section 8 and the centerline of State Route 116, a distance of 885.10 feet to a railroad spike found. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, North 00°12'45" West, along the last described line, a distance of 50.00 feet to a Mag nail set -

Thence, South 89°27'15" West, passing through 5/8 inch iron bars set at 30.00 feet 554.73 feet, a total distance of 883.80 feet to a 5/8 inch iron bar set -

Thence, North 00°12'45" West, a distance of 394.93 feet to a 5/8 inch iron bar set -

Thence, South 89°26'43" West, along the north line of the south half of the southeast quarter of said Section 8, passing through a 5/8 inch iron bar set at 544.18 feet, a total distance of 594.18 feet to a point in the approximate centerline of an existing Creek -

Thence, leaving the approximate centerline of said Creek, North 89°27'15" East, along the north line of a 9.294 acre parcel of land conveyed to Dennis and Adele Walls by deed recorded at Official Record 161, page 471, passing through 5/8 inch iron bars found at 694.59 feet and 1219.32 feet, a total distance of 1249.32 feet to the place of beginning.
