DAVID STEVELEY SURVEY 3.500 ACRE TRACT

The following described tract of land is part of the Southwest Quarter of Section 1, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio, being part of Parcel No. B05-001-006-00 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Northeast Corner of the Northwest Quarter of the Southwest Quarter of Section 1, Duchouquet Township and in the intersection of the centerlines of Township Road 196 (Freymuth Road) and Township Road 183 (Mudsock Road);

Thence N.89°23'28"W. along the legal centerline of Township Road 196 and the North line of the Southwest Quarter of said Section 1, a distance of 595.39 feet to a Mag Nail (found) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°45'23"W. a distance of 396.10 feet to an iron pin (set), passing thru an iron pin (found) at 16.50 feet in the South right-way line of Township Road 196 and passing thru an iron pin found at 310.00 feet;

Thence N.89°23'28"W., parallel to the centerline of Township Road 196, a distance of 385.00 feet to an iron pin (set);

Thence N.00°45'23"E. a distance of 396.10 feet to a Mag Nail (set), passing thru an iron pin (set) at 379.60 feet in the South right-of-way line of Township Road 196;

Thence S.89°23'28"E., along the legal centerline of Township Road 196 and the North line of the Southwest Quarter of said Section 1, a distance of 385.00 feet to the Mag Nail (found), which was the true PLACE OF BEGINNING.

Containing in all 3.500 Acres of which 0.145 Acre has been used for highway purposes and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 667, Page 760. This plat is recorded in Survey Book "T", Page 546, in the Auglaize County Engineer's Office. Basis of bearings for this tract is holding the North line of the Southwest Quarter of Section 1, Duchouquet Township and the centerline of Township Road 196 as N.89°23'28"W. from the Ohio State Plane-North Coordinate System NAD83 (2011).
