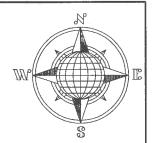

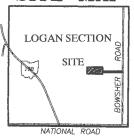

## AARON HOUSER SURVEY 5.100 ACRE TRACT

The following described tract of land is located in the Southeast part of Logan's Section, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, being part of Parcel No. F19-026-010-01 and is more particularly described as follows:

Commencing at a Monument Box (found) at the intersection of the centerlines of County Road 208 (National Road) and County Road 121 (Bowsher Road);

Thence N.00°43'23"E. along the centerline of County Road 121, a distance of 1,892.19 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.89°16'42"W. a distance of 815.77 feet to an iron pin (set), passing thru an iron pin (set) for reference at 25.00 feet in the West right-of-way line of County Road 121;

Thence S.00°43'23"W., parallel to the centerline of County Road 121, a distance of 69.83 feet to an iron pin (set);

Thence N.89°16'43"W. a distance of 651.01 feet to an iron pin (set);

Thence N.00°07'25"E. a distance of 278.01 feet to an iron pin (set);

Thence S.89°16'43"E. a distance of 653.92 feet to an iron pin (set);

Thence S.00°43'17"W. a distance of 158.16 feet to an iron pin (found);

Thence S.89°16'42"E. a distance of 815.77 feet to a Mag Nail (found), passing thru an iron pin (found) at 790.77 feet in the West Right-of-Way line of County Road 121;

Thence S.00°43'23"W. along the centerline of County Road 121, a distance of 50.00 feet to the Mag Nail (set) which was the true PLACE OF BEGINNING.

Containing in all 5.100 Acres of which 0.028 Acre has been used for highway purposes and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
