

Parcel "B" LEGAL DESCRIPTION

Being a part of Parcel #B05-012-009-03 and being a part of the W ½ of the NW ¼ of Section 12, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 154, Pg. 760), more particularly described as follows:

Commencing at an existing Monument Box at the SW corner of the NW $\frac{1}{2}$ of Section 12; thence N 00°-51′-32″ E with the W line of the NW $\frac{1}{2}$ of Section 12, 250.00′ to a #5 Rebar set at the POINT OF BEGINNING; thence the following courses:

- 1. Continuing N 00°-51′-32″ E with said fractional section line, 59.54′ to an existing #5 Rebar;
- 2. S 89°-31'-13" E, 250.00' to a set #5 Rebar;
- 3. S 00°-51′-32″ W, 59.54′ to a point as referenced by an existing $\frac{1}{2}$ ″ Rebar at (0.65′ S, 1.30′ E);
- 4. N 89°-31'-11" W, 250.00' to the POINT OF BEGINNING.

The above described parcel contains 0.342 acres, more or less, subject to all legal highways and easements of record.

The system of bearings for this legal description is based on Ohio State Plane – North Coordinate System NAD83 (2011). Parcel "A + B" LEGAL DESCRIPTION

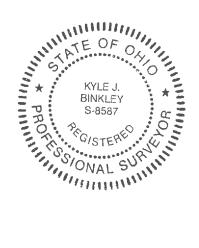
Being Parcel #B05-012-009-01 & part of Parcel #B05-012-009-03 and being a part of the W½ of the NW¼ of Section 12, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio (Prior Deeds Referenced in O.R. 154, Pg. 760 & D.V. 229, Pg. 465), more particularly described as follows:

Beginning at an existing Monument Box at the SW corner of the NW ¼ of Section 12; thence the following courses:

- 1. N 00°-51′-32" E with the W line of the NW ¼ of Section 12, 309.54' to an existing #5 Rebar, passing a set #5 Rebar at 20.00' and 250.00';
- 2. S 89°-31'-13" E, 250.00' to a set #5 Rebar;
- 3. S 00°-51′-32″ W, 309.54′ to a Mag Nail set on the S line of the NW ¼ of Section 12 (centerline of Seitz Road), passing a point as referenced by an existing ½″ Rebar at (0.65′ S, 1.30′ E) and passing a set #5 Rebar at 289.54′;
- 4. N 89°-31'-11" W with said fractional section line, 250.00' to the POINT OF BEGINNING.

The above described parcel contains 1.776 acres, more or less, of which 0.115 acres are occupied by road right-of-way, subject to all legal highways and easements of record.

Commencing at an existing Monument Box at the SW corner of the NW ¼ of Section 12; thence S 89°-31′-11″ E with the S line of the NW ¼ of Section 12, 400.26′ to a Mag Nail set at the POINT OF BEGINNING; thence the following courses:

- 1. N 00°-48′-39" E, 309.54' to a set #5 Rebar, passing a set #5 Rebar at 20.00';
- 2. S 89°-31'-13" E, 262.93' to an existing #5 Rebar;
- 3. S 00°-58′-08" W, 309.55' to an existing Railroad Spike on the S line of the NW ¼ of Section 12 (centerline of Seitz Road), passing an existing #5 Rebar at 289.55';
- 4. N 89°-31'-11" W with said fractional section line, 262.08' to the POINT OF BEGINNING.

The above described parcel contains 1.865 acres, more or less, of which 0.120 acres are occupied by road right-of-way, subject to all legal highways and easements of record.
