## FLEDDERJOHANN SURVEY PT. PARCEL K3002500101 3.500 ACRES

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 25 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY WAYNE AND KIMBERLY FLEDDERJOHANN (TRUSTEE) AS RECORDED IN OFFICIAL RECORD 686 PAGE 1653 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Commencing at an A.C.E.O. Monument Box found at the northeast corner of the southeast quarter of said Section 25,

Thence, with the east line of the southeast quarter of said Section 25 and the centerline of East Shelby Road, South 01°03'09" West, 256.44 feet to a Mag Nail set, said Mag Nail marking the **Point of Beginning** of the tract herein described;

Thence, continuing with the east line of the southeast quarter of said Section 25 and the centerline of East Shelby Road, South 01°03'09" West, 220.72 feet to a Mag Nail set at the intersection lines of East Shelby Road and New Bremen-New Knoxville Road;

Thence, following the center of the right of way of New Bremen-New Knoxville Road the following 2 courses;

- 1. South 68°02'40" West, 153.24 feet to an iron pin found with "A.C.E.O." cap;
- 2. South 25°40'03" West, 88.06 feet to a Mag Nail set;

Thence, with a new division line, North 77°07'04" West, 329.25 feet to an iron pin set, passing for reference at 30.76 feet an iron pin set in the west right of way line of New Bremen-New Knoxville Road;

Thence, with the east line of a 109.2 acre tract of land owned by W. and K. Fledderjohann (Trustee) as recorded in Official Record 641, Page 1386, North 01°04'18" East, 293.17 feet to an iron pin set,

Thence, with a new division line, South 88°56'51" East, 499.88 feet to the **Point of Beginning** containing 3.500 acres more of less with 0.251 acres in the right of way of New Bremen-New Knoxville Road and East Shelby Road, passing for reference at 479.93 feet an iron pin set in the west right of way line of East Shelby Road and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
