THENCE, NORTH 04'-33'-45" WEST, 49.00 FEET, ALONG THE EAST RIGHT-OF-WAY LINE OF WASHINGTON STREET (S.R. 66) TO AN IRON PIN WITH CAP SET;

THENCE, NORTH 83'-17'-30" EAST, 12.01 FEET, ALONG THE EAST RIGHT-OF-WAY LINE OF WASHINGTON STREET (S.R. 66) TO AN IRON PIN WITH CAP SET;

THENCE, NORTH 03°-22'-01" EAST, 36.26 FEET, ALONG THE EAST RIGHT-OF-WAY LINE OF WASHINGTON STREET (S.R. 66) TO AN IRON PIN WITH CAP SET;

THENCE, NORTH 69°-26'-16" EAST, 22.66 FEET, ALONG THE EAST RIGHT-OF-WAY LINE OF WASHINGTON STREET (S.R. 66) AND THE SOUTH RIGHT-OF-WAY LINE OF MONROE STREET (S.R. 274) TO A MAG NAIL SET;

THENCE, NORTH 85'-05'-07" EAST, 85.60 FEET, ALONG THE SOUTH RIGHT-OF-WAY LINE OF MONROE STREET (S.R. 274) TO A MAG NAIL SET;

THENCE, NORTH 82°-36'-47" EAST, 8.26 FEET, ALONG THE SOUTH RIGHT-OF-WAY LINE OF MONROE STREET (S.R. 274) TO A MAG NAIL SET ON THE CENTERLINE OF A VACATED 16.5' ALLEY BY ORDINANCE 2007-6-28 AND THE NORTHWEST CORNER OF A TRACT OF LAND OWNED BY CROWN CONTROL CORPORATION AS DESCRIBED IN OFFICIAL RECORD 142, PAGE 523;


