

Being Part of the Southeast Fractional Quarter of Section 28, T-6-S, R-7-E, Clay Township, Auglaize County, Ohio.






This Plat is Recorded in Survey Book "T", Page 608 in the Auglaize County Engineer's Office.

HELMLINGER SURVEY 33.026 ACRE TRACT

The following described tract of land is part of the Southeast Fractional Quarter of Section 28, Town 6 South, Range 7 East, Clay Township, Auglaize County, Ohio, being part of Parcel No. A02-281-002-00 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Southwest corner of the Southeast Fractional Quarter of Section 28, Clay Township and in the centerline of Township Road 90 (Southland Road);

Thence S.89°22'04"E. along the legal centerline of Township Road 90 and the South line of the Southeast Fractional Quarter of Section 28, Clay Township, a distance of 1,325.44 feet to a R.R. Spike (found), which is the PLACE OF BEGINNING for the tract of land herein described;

Thence with the East line of the Paul E. and Sue A. Schaub (Trustees) 39.915 acre tract as described in O.R. Volume 696, page 3,711, N.01°01'17"E. a distance of 1,308.67 feet to an iron pin (set), passing thru an iron pipe (found) at 20.00 feet;

Thence with the North line of said 39.915 acre tract, N.89°22'04"W. a distance of 1,330.73 feet to an iron pipe (found);

Thence with the East line of the Paul E. and Sue A. Schaub (Trustees) 59.253 acre tract as described in O.R. Volume 696, page 3,711, N.00°47'23"E. a distance of 738.50 feet to an iron pipe over a corner stone (found, survey by Thomas W. Steinke, "F"-47) in the Indian Treaty Lewistown Reservation Line;

Thence N.83°55'08"E. along said Indian Treaty Lewistown Reservation Line, a distance of 1,164.03 feet to an iron pin (set);

Thence S.16°18'04"E. along the Western right-of-way line of the Indiana and Ohio Railroad, a distance of 2,282.16 feet to a Mag Nail (set), passing thru an iron pin (set) for reference at 2,261.25 feet;

Thence N.89°22'04"W. along the legal centerline of Township Road 90 and the South line of the Southeast Fractional Quarter of said Section 28, a distance of 500.94 feet to the R.R. Spike (found) which was the true PLACE OF BEGINNING.
