

Parcel "A" LEGAL DESCRIPTION

Being a part of Parcel #K32-053-010-00 and being a part of Outlot #118 of the City of St. Marys and being a located in the SW ¼ of Section 2, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 92, Pg. 1038), more particularly described as follows:

Commencing at an existing Railroad Spike at the SW corner of Section 2 and being the SW corner of Outlot #117 of the City of St. Marys; thence N 00°-57'-41" E with the W line of the SW ¼ of Section 2 (centerline of Beech Street), 300.00' to a set Mag Nail; thence S 89°-04'-59" E, 25.00' to an existing Concrete Monument on the Westerly right-of-way line of Beech Street; thence N 00°-57'-41" E with said Westerly right-of-way, 115.47' to a #5 Rebar set on the S line of said Outlot #118 and being the POINT OF BEGINNING; thence the following courses:

- 1. Continuing N 00°-57'-41" E with said Westerly right-of-way, 161.57' to a set #5 Rebar;
- 2. N 88°-48'-58" E, 297.18' to a point, passing an existing 1" Iron Pin at 296.63';
- 3. S 01°-01′-37" W, 168.89' to a point on the S line of said Outlot #118, as referenced by an existing #5 Rebar at (2.24' N, 0.11' E);
- 4. N 89°-46′-19" W with the S line of said Outlot #118, 296.81' to the POINT OF BEGINNING.

The above described parcel contains 1.126 acres, more or less, subject to all legal highways and easements of record.

- 1. N 00°-57'-41" E with said Westerly right-of-way, 115.47' to a #5 Rebar set on the N line of said Outlot #117;
- 2. S 89°-46'-19" E on the N line of said Outlot #117, 256.81' to an existing #5 Rebar;
- 3. S 38°-02'-20" E, 152.46' to a set #5 Rebar;
- 4. N 89°-04'-59" W, 352.73' to the POINT OF BEGINNING.
