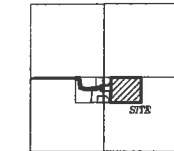

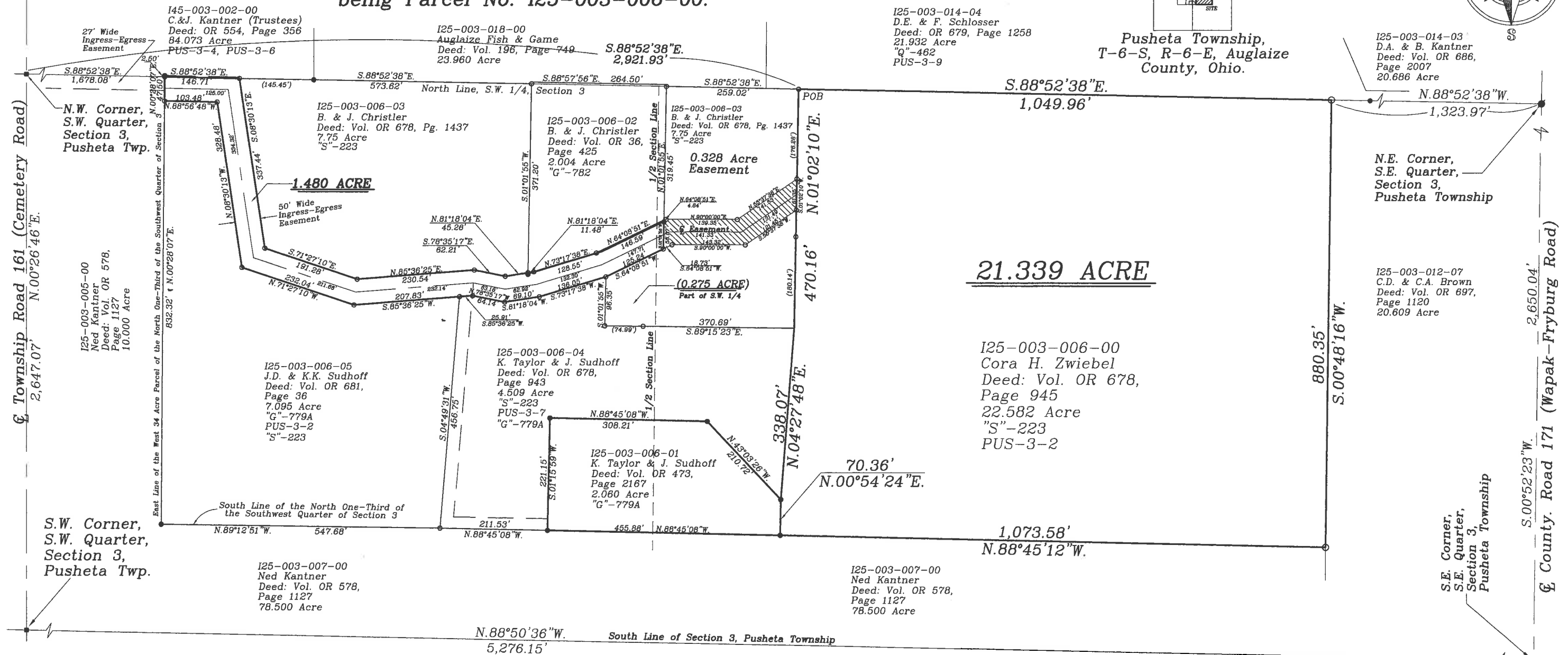
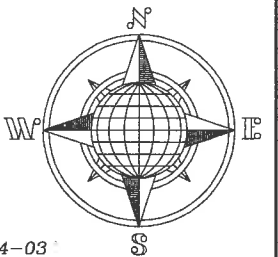

County, Ohio.



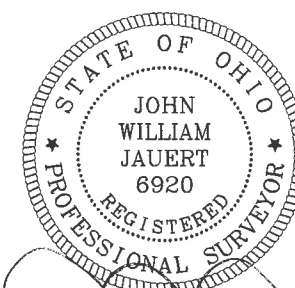
