Commencing at a Monument Box (found) at the Northwest corner of the Northwest Quarter of Section 9, Duchouquet Township and in the intersection of the centerlines of County Road 190 (Buckland-Holden Road) and County Road 151 (Wapakoneta-Cridersville Road);

Thence S.89°04'55"E. along the centerline of County Road 190 and the North line of the Northwest Quarter of said Section 9, a distance of 1,763.30 feet to a Mag Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°04'55"E. along the above described line, a distance of 307.24 feet to a Mag Nail (found);

Thence S.00°55'04"W. a distance of 348.48 feet to an iron pin (found), passing thru an iron pin (found) at 25.00 feet in the South right-of-way line of County Road 190;

Thence N.89°04'55"W. a distance of 110.00 feet to an iron pin (set);

Thence N.89°04'55"W. a distance of 285.00 feet to an iron pin (set);



Thence S.00°45'46"W. along the East line of the Northwest Quarter of said Section 9, a distance of 1,993.31 feet to an iron pin (set), passing thru iron pins set at 25.00 feet and 1,328.87 feet respectfully;

Thence N.89°09'16"W. a distance of 2,653.44 feet to a Mag Nail (set) in the centerline of County Road 151 (Wapakoneta-Cridersville Road), passing thru iron pin (set) at 1,326.72 feet and 2,621.44 feet respectfully;

Thence N.00°41'30"E. along the centerline of County Road 151 and the West line of the Northwest Quarter of said Section 9, a distance of 1,331.11 feet to a Mag Nail (set);
