

The following described parcel of land is situated in the southeast quarter of Section 10, Township 6 South, Range 7 East, Clay Township, Auglaize County, Ohio, being part of Parcel A0301000900, also being the northwest guarter of the southeast guarter of Section 10 as described in O.R. 470, Page 1505 and is more particularly described as follows:

Beginning at a monument box marking the northwest corner of the southeast quarter of Section 10 also being the centerline of Clay Road;

thence with the centerline of Clay Road S 88° 59' 44" E, a distance of 1,321.50 feet to a mag nail (found);

thence S 00° 50' 02" W, a distance of 1,325.43 feet to a 5/8 inch iron pin (set) passing at 20.00 feet a 5/8 inch iron pin (set);

thence N 88° 52' 29" W, a distance of 1,325.67 feet to a 5/8 inch iron pin (set); thence N 01° 00' 50" E, a distance of 1,322.63 feet to the POINT OF BEGINNING passing at 618.39 feet a 2 inch iron pipe post (found) and at 1,302.63 feet a 5/8 inch iron pin (set). This parcel contains 40.231 acres, more or less, subject to all legal highways and easements of record. This description is based on a field survey performed in January, 2020 and was prepared by Leland D. Yoakam L.S. No 7676.
