SURVEYOR'S DESCRIPTION 0.544 Acre "Add-On" Parcel

The following described parcel of land is a part of the Southwest Quarter of Section 14, Clay Township, Town-6-South, Range-7-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box (found) situated at the Northeast corner of the Southwest Quarter of said Section 14, Clay Township, Town-6-South, Range-7-East;

Thence with a bearing of N. 88°-46'-25" W. along the North line of the Southwest Quarter of said Section 14, Clay Township, and the centerline of Gutman Road (County Road #116) for a distance of 519.00 feet to a Mag Nail (found) at the Northeast corner of permanent parcel #A03-014-004-00;

Thence continuing with a bearing of N. 88°-46'-25" W. along the North line of the Southwest Quarter of said Section 14, Clay Township, and the centerline of Gutman Road (County Road #116) for a distance of 210.00 feet to a Mag Nail (found) at the Northwest corner of permanent parcel #A03-014-004-00 and the PLACE OF BEGINNING;

Thence with a bearing of S. 00°-52'-50" W. along the West line of permanent parcel #A03-014-004-00 for a distance of 232.50 feet to a point, and passing thru an Iron Pin (found) for reference at a distance of 25.00 feet;

Thence with a bearing of N. 88°-46'-25" W. and parallel with the North line of the Southwest Quarter of said Section 14, Clay Township, and the centerline of Gutman Road (County Road #116) for a distance of 102.00 feet to a wood stake (set);

Thence with a bearing of N. 00° -52'-50" E. and parallel with the West line of permanent parcel #A03-014-004-00 for a distance of 232.50 feet to a Mag Nail (set), and passing thru an Iron Pin (set) for reference at a distance of 207.50 feet;

Thence with a bearing of S. 88°-46'-25" E. along the North line of the Southwest Quarter of said Section 14, Clay Township, and the centerline of Gutman Road (County Road #116) for a distance of 102.00 feet to a Mag Nail (found) at the Northwest corner of permanent parcel #A03-014-004-00 and the original PLACE OF BEGINNING.

The above described parcel of land contains 0.059 Acre previously dedicated for highway purposes, and is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

The basis of bearings used for this description were determined from the Auglaize County Engineer's Global Positioning Survey and Coordinate System whereas the North line of the Southwest quarter of said Section 14, Clay Township, and the centerline of Gutman Road (County Road #116), bears N. 88°-46'-25" W.
