

## Parcel "A" LEGAL DESCRIPTION

Being a part of Parcels #F19-026-001-00 & F19-027-011-12 (Prior Deed Referenced in O.R. 701, Pg. 5233) of the NE  $\frac{1}{2}$  of Section 27 and part of the NW  $\frac{1}{2}$  of Section 26, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, more particularly described as follows:

Beginning at an existing Monument Box at the NW corner of the NW ¼ of Section 26; thence the following courses:

- 1. S 89°-03'-11" E with the N line of the NW ¼ of Section 26 (centerline of Zerkle Road), 1160.05' to a set Mag Nail;
- 2. S 00°-47'-47" W, 915.18' to a set #5 Rebar, passing a set #5 Rebar at 20.00';
- 3. N 89°-03'-11" W, 1419.03' to a Mag Nail set in the centerline of State Route 198, passing a set #5 Rebar at 1367.94';
- 4. N 10°-56′-03″ W with the centerline of State Route 198, 911.78′ to an existing Railroad Spike at Sta. 491+78.20, passing an existing Mag Spike at 233.57′, Sta. 485+00;
- 5. N 08°-19'-03" W, 21.72' to a point at the intersection of the centerline of State Route 198 and the N line of the NE ¼ of Section 27 (centerline of Zerkle Road), as referenced by an existing Railroad Spike at N 42°-42'-32" W, 1.05';
- 6. S 89°-14'-39" E with said fractional section line, 447.80' to the POINT OF BEGINNING.

The above described parcel contains 31.802 acres, more or less, of which 1.958 acres are occupied by road right-of-way, subject to all legal highways and easements of record.

## Parcel "B" LEGAL DESCRIPTION

Being a part of Parcel #F19-026-002-00 and being a part of the W ½ of the Logan Section & part of Parcels #F19-026-001-00 & F19-027-011-12 (Prior Deed Referenced in O.R. 701, Pg. 5233) of the NE ¼ of Section 27 and part of the NW ¼ of Section 26, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, more particularly described as follows:

Commencing at the intersection of the centerline of State Route 198 and the N line of the NE ¼ of Section 27 (centerline of Zerkle Road), as referenced by an existing Railroad Spike at N 42°-42′-32″ W, 1.05′; thence S 08°-19′-03″ E with the centerline of State Route 198, 21.72′ to an existing Railroad Spike at Sta. 491+78.20; thence S 10°-56′-03″ E continuing with said centerline, 911.78′ to a Mag Nail set at the POINT OF BEGINNING, passing an existing Mag Spike at 678.21′, Sta. 485+00; thence the following courses:

- 1. \$ 89°-03'-11" E, 1419.03' to a set #5 Rebar, passing a #5 Rebar set at 51.09';
- 2. S 00°-47'-47" W, 400.32' to a #5 Rebar set on the N line of the Logan Section;
- 3. S 00°-49'-40" W, 187.88' to a set #5 Rebar;
- 4. S 34°-30'-13" W, 71.90' to a set #5 Rebar;
- 5. N 89°-29'-24" W, 1250.74' to a Mag Nail set on the centerline of State Route 198, passing a set #5 Rebar at 1135.32' and 1200.09';
- 6. N 08°-48'-34" W with the centerline of State Route 198, 219.99' to an existing Mag Spike at Sta. 478+15.92;
- 7. N 10°-56′-03" W with said centerline, 450.50′ to the POINT OF BEGINNING, passing an existing Mag Spike at the intersection of the centerlines of Place Road and State Route 198 at 49.19′, Sta. 478+65.11.

The above described parcel contains 20.240 acres, more or less, of which 0.769 acres are occupied by road right-of-way, subject to all legal highways and easements of record.
