



Description for 117.816 Acres

Situated

in the Southeast Quarter and Northeast Quarter of Section 12, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio, being part of a tract heretofore conveyed to James J. and Ruth L. Hardin by deed recorded in Official Record Volume 675, Page 1827, and being more particularly described as follows:

Commencing

at the southwest corner of the Southeast Quarter of said Section 12, being a monument box found;

Thence

along the west line of said southeast quarter, N.00°56'23"E., a distance of 529.25 feet to the *Principal Point* of Beginning, being a 5/8" iron pin set;

Thence

continuing along said west line and the west line of the northeast quarter, N.00°56'23"E., a distance of 4432.07 feet to a 8" wood post found at the southwest corner of a one-half acre tract as described in Official Record Volume 590, Page 1719;

Thence

along the south line of said one-half acre tract, S.89°55'36"E., a distance of 174.35 feet to a 8" wood post found at the southeast corner of said one-half acre tract;

Thence

along the southwest line of the former Indiana, Columbus and eastern Traction Company lands, S.34°06'06"E., a distance of 1997.78 feet to a 5/8" iron pin found at the southwest corner of one-half acre tract as described in Official Record Volume 675, Page 1827;

Thence

running along said tract on the following two (2) courses and distances:

1. N.00°50'25"E., a distance of 139.68 feet to a 5/8" iron pin set;

2. S.34°06'06"E., a distance of 561.49 feet to a 5/8" iron pin set in the north line of a 10.020 acre tract as described in Official Record Volume 703, Page 4523;

Thence

along the north line of said 10.020 acre tract, S.81°29'18"W., a distance of 333.74 feet to a rail road rail post found;

Thence

along the west line of said 10.020 acre tract, S.00°09'36"W., a distance of 310.59 feet to a 5/8" iron pin set;

Thence

along the east line of the west half of said southeast quarter, S.00°54'01"W., a distance of 2380.40 feet to the northeast corner of a 1.000 acre tract as described in Official Record Volume 21, Page 784;

Thence

running along said 1.000 acre tract on the following two (2) courses and distances:

1. N.89°17'49"W., a distance of 150.00 feet to a point;

2. S.00°54'01"W., a distance of 257.00 feet to a mag nail set in the south line of said southeast quarter;

Thence

along said south line, N.89°17'49"W., a distance of 5.70 feet to a spike found at the southeast corner of a 2.000 acre tract as described in Official Record Volume 587, Page 189;

Thence

running along said 2.000 acre tract on the following three (3) courses and distances:

- N.00°52'11"E., a distance of 289.18 feet to a 8" wood post found, passing a 5/8" iron pin found at 25.00 feet:
- 2. N.89°17'49"W., a distance of 301.27 feet to a wood post found;
- 3. S.00°52'11"W., a distance of 289.18 feet to a spike found in the south line of said southeast quarter, passing a 5/8" iron pin found at 264.18 feet;

along said south line, N.89°17'49"W., a distance of 40.00 feet to a mag nail set;

Thence

on a new division line on the following two (2) courses and distances:

- 1. N.00°52'11"E., a distance of 529.25 feet to a point, passing a 5/8" iron pin set at 25.00 feet;
- 2. N.89°17'49"W., a distance of 822.72 feet to the Principal Point of Beginning;
