

PARCEL 1 LEGAL DESCRIPTION

Being Part of Parcel #G22-013-010-00 as described in Deed Volume 202, Page 86 of the Auglaize County Record of Deeds. Situated in the NE ¼ of Section 13, T-5-S, R-5-E, Moulton Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a monument box found at the northeast corner of said NE ¼ of Section 13, also being on the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along the north line of said NE ¼ of Section 13, also being the centerline of Wapakoneta-Buckland Road (TR 180), N 88°-55'-41" W (basis of bearing) a distance of 1,201.22 feet to a mag nail found marking the intersection of the centerline of State Route 198 and the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along said centerline of State Route 198, S 24°-52'-46" E a distance of 654.50 feet to a set mag nail being the POINT OF BEGINNING for the tract of land herein described;

thence N 65°-22'-12" E a distance of 170.04 feet to a ¾ inch iron stake found marking the southeast corner of Lot 9 located in Brookhart Subdivision recorded in Plat Book B, Page 32, passing a set 5/8 inch iron pin capped at a distance of 30.00 feet marking the east right-of-way line of State Route 198, also being the southwest corner of said Lot 9;

thence along the entire east line of said Lot 9 and along a portion of the east line of Lot 8 located in said Brookhart Subdivision, N 24°-56'-55" W a distance of 180.71 feet to a set 5/8 inch iron pin capped;

thence parallel with said centerline of State Route 198, S 24°-52'-46" E a distance of 165.21 feet to a set 5/8 inch iron pin capped;

thence S 22°-47'-50" W a distance of 51.52 feet to a set 5/8 inch iron pin capped;

thence S 63°-22'-39" W a distance of 170.14 feet to a set mag nail on said centerline of State Route 198, passing a set 5/8 inch iron pin capped at a distance of 140.13 feet marking said east right-of-way line of State Route 198;

thence along said centerline of State Route 198, N 24°-52'-46" W a distance of 26.86 feet to the POINT OF BEGINNING.

Situated in the NE ¼ of Section 13, T-5-S, R-5-E, Moulton Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a monument box found at the northeast corner of said NE ¼ of Section 13, also being on the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along the north line of said NE ¼ of Section 13, also being the centerline of Wapakoneta-Buckland Road (TR 180), N 88°-55'-41" W (basis of bearing) a distance of 1,201.22 feet to a mag nail found marking the intersection of the centerline of State Route 198 and the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along said centerline of State Route 198, S 24°-52'-46" E a distance of 465.01 feet to a point;

TWENTY (20) FOOT SANITARY SEWER EASEMENT LEGAL DESCRIPTION

Being a twenty (20) foot wide easement for the purpose of an existing sanitary sewer line running across a 3.528 acre tract of land being Parcel #G22-013-010-00 as described in Deed Volume 202, Page 86 of the Auglaize County Record of Deeds and running across a 0.791 acre tract of land being Parcel #G22-013-010-06 as described in OR Volume 533, Page 2269 of the Auglaize County Official Record of Deeds. Situated in the NE ¼ of Section 13, T-5-S, R-5-E, Moulton Township, County of Auglaize, State of Ohio the centerline which is more particularly described as follows:

Commencing at a monument box found at the northeast corner of said NE ¼ of Section 13, also being on the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along the north line of said NE ¼ of Section 13, also being the centerline of Wapakoneta-Buckland Road (TR 180), N 88°-55'-41" W (basis of bearing) a distance of 1,201.22 feet to a mag nail found marking the intersection of the centerline of State Route 198 and the centerline of Wapakoneta-Buckland Road (TR 180);

Thence along said centerline of State Route 198, S 24°-52'-46" E a distance of 681.36 feet to a set mag nail;
