


Duchouquet Township, T-5-S, R-6-E, Auglaize County, Ohio.



The following described tract of land is part of the Northeast and Northwest Quarters of Section 26, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio, being Parcel No. B05-026-002-00 and is more particularly described as follows:

The PLACE OF BEGINNING is at a Monument Box (found) at the Southwest corner of the Northwest Quarter of Section 26, Duchouquet Township and in the centerline of Township Road 171 (Bachman Road);

Thence N.00°44'53"E. along the West line of the Northwest Quarter of said Section 26 and along the centerline of Township Road 171, a distance of 1,327.13 feet to a Mag Nail (set);

Thence N.89°48'34"E. along the North line of the South one-half of the Northwest Quarter of said Section 26, a distance of 2,617.48 feet to a 5/8-inch iron pin (set), passing thru a 5/8-inch iron pin (set) for reference at 15.00 feet in the occupied right-of-way line of Township Road 171;

Thence N.45°12'57"E. a distance of 28.48 feet to a 5/8-inch iron pin (set);

Thence N.00°37'20"E. along the East line of the Northwest Quarter of Section 26, a distance of 643.96 feet to a 5/8-inch iron pin (set);

Thence N.89°45'58"E. a distance of 1,317.90 feet to a 5/8-inch iron pin (set);

Thence S.00°33'40"W. a distance of 664.42 feet to a 10-inch wood post (found);

Thence S.89°47'11"W.along the South line of the North one-half of the Northeast Quarter of said Section 26, a distance of 1,318.60 feet to a 5/8-inch iron pin (set);

Thence S.00°37'20"W.along the East line of the Northwest Quarter of said Section 26, a distance of 1,327.92 feet to a 12-inch concrete post (found) at the Southeast corner of the Northwest Quarter of said Section 26, Duchouquet Township;


Thence S.89°49'39"W. along the South line of the Northwest Quarter of Section 26, a distance of 2,640.39 feet to the Monument Box at the Southwest corner of the Northwest Quarter of said Section 26 which was the true PLACE OF BEGINNING.
