



Legal Description for 10.644 Acres

Situate in the Northwest Quarter of Twenty-three (23), Town Six (6) South, Range Six (6) East, Township of Pusheta, County of Auglaize, State of Ohio, and being part of a tract (part of parcel number I2502300600) as conveyed to Scott Moell in Official Record 364, Page 32 of the Recorder's office of Auglaize County, Ohio, as shown by a survey by Britt R. Havenar, Ohio P.S. No. 8266, and filed in Survey Book _____ of the Auglaize County Engineer's Record of Land Surveys and being more particularly described as follows:

Commencing at a stone found in a monument box at the southeast corner of the northwest quarter of Section of Twenty-three (23), Town Six (6) South, Range Six (6) East, said stone being on the centerline of right-of-way of Shelby-Freyburg Road (40' R/W), thence North 00 degrees 54 minutes 08 seconds East, along said centerline of right-of-way, a distance of 667.50 feet to an iron pin found;

Thence North 38 degrees 09 minutes 50 seconds West, along said centerline of right-of-way, a distance of 203.72 feet to a railroad spike found;

Thence North 37 degrees 37 minutes 40 seconds West, along said centerline of right-of-way, a distance of 171.88 feet to a Mag spike set, said spike being the True Point of Beginning of the tract of land herein described;

Thence North 88 degrees 55 minutes 02 seconds West, a distance of 366.42 feet to a capped iron pin set, passing through a capped iron pin set at a distance of 25.63 feet which marks the west right-of-way line of Shelby-Freyburg Road;

Thence South 36 degrees 23 minutes 11 seconds West, a distance of 217.15 feet to a capped iron pin set;

Thence North 88 degrees 55 minutes 30 seconds West, a distance of 237.62 feet to a capped iron pin set;

Thence South 18 degrees 55 minutes 06 seconds West, a distance of 360.14 feet to a capped iron pin set;

Thence North 88 degrees 12 minutes 36 seconds West, a distance of 1017.40 feet to a pinched pipe found;

Thence North 00 degrees 57 minutes 06 seconds East, a distance of 370.72 feet to a capped iron pin set;

Thence South 88 degrees 52 minutes 58 seconds East, a distance of 808.04 feet to a stone found;

Thence South 88 degrees 55 minutes 30 seconds East, a distance of 538.97 feet to an iron pin found;

Thence North 01 degrees 10 minutes 53 seconds East, a distance of 207.08 feet to an iron pin found;

Thence South 88 degrees 55 minutes 02 seconds East, a distance of 454.66 feet to a gin spindle found; passing through an iron pin found at a distance of 422.62 feet, said gin spindle being on the centerline of right-of-way of Shelby-Freyburg Road;

Thence South 37 degrees 37 minutes 40 seconds East, along said centerline of right-of-way, a distance of 89.53 feet to a Mag spike set, said spike being the True Point of Beginning of the above described tract, containing 10.644 acres more or less, subject to all easements of record, of which .041 acres are in the present right-of-way.

Situate in the Northwest Quarter of Twenty-three (23), Town Six (6) South, Range Six (6) East, Township of Pusheta, County of Auglaize, State of Ohio, and being part of a tract (part of parcel number I2502300600) as conveyed to Scott Moell in Official Record 364, Page 32 of the Recorder's office of Auglaize County, Ohio, as shown by a survey by Britt R. Havenar, Ohio P.S. No. 8266, and filed in Survey Book _____, Page _____ of the Auglaize County Engineer's Record of Land Surveys and being more particularly described as follows:

Commencing at a stone found in a monument box at the southeast corner of the northwest quarter of Section of Twenty-three (23), Town Six (6) South, Range Six (6) East, said stone being on the centerline of right-of-way of Shelby-Freyburg Road (40' R/W), thence North 00 degrees 54 minutes 08 seconds East, along said centerline of right-of-way, a distance of 667.50 feet to an iron pin found;

Thence North 38 degrees 09 minutes 50 seconds West, along said centerline of right-way, a distance of 203.72 feet to a railroad spike found, said spike being the True Point of Beginning of the tract of land herein described;

Thence North 88 degrees 50 minutes 51 seconds West, a distance of 365.49 feet to a 3/4" diameter iron pipe found, passing through a wood post found at a distance of 33.75 feet;

Thence South 01 degrees 55 minutes 27 seconds East, a distance of 366.97 feet to a 3/4" diameter iron pipe found;

Thence South 83 degrees 24 minutes 47 seconds West, a distance of 187.83 feet to a 3/4" diameter iron pipe found;

Thence North 88 degrees 12 minutes 36 seconds West, a distance of 414.98 feet to a capped iron pin set;

Thence North 18 degrees 55 minutes 06 seconds East, a distance of 360.14 feet to a capped iron pin set;

Thence South 88 degrees 55 minutes 30 seconds East, a distance of 237.62 feet to a capped iron pin set;

Thence North 36 degrees 23 minutes 11 seconds East, a distance of 217.15 feet to a capped iron pin set;

Thence South 88 degrees 55 minutes 02 seconds East, a distance of 366.42 feet to a Mag spike set, passing through a capped iron pin set at a distance of 340.79 feet which marks the west right-of-way line of Shelby-Freyburg Road, said spike being on the centerline of right-of-way of Shelby-Freyburg Road;

Thence South 37 degrees 37 minutes 40 seconds East, along said centerline of right-of-way, a distance of 171.88 feet to a railroad spike found, said spike being the True Point of Beginning of the above described tract, containing 5.882 acres more or less, subject to all easements of record, of which 0.079 acres are in the present right-of-way.
