

Parcel "B" LEGAL DESCRIPTION

Being a part of Parcel #M39-014-099-00 (Prior Deed Referenced in O.R. 705, Pg. 2860) and being a part of Outlot 39 of the Village of New Knoxville and being located in the NE ¼ of Section 30, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio, more particularly described as follows:

Commencing at a Mag Spike set at the intersection of the centerline of German Street and the E line of Outlot 39 and being the centerline of a 16.5' Alley as shown in the plat of Bielefeld's Subdivision (P.B. 2, Pg. 95); thence N 89°-21'-06" W with the centerline of German Street, 8.25' to a set Mag Spike on the W line of said Alley; thence N 01°-19'-24" W with the W line of said Alley, 6.51' to a set #5 Rebar; thence N 89°-32'-27" W, 91.00' to a #5 Rebar set at the POINT OF BEGINNING; thence the following courses:

- 1. S 01°-19'-24" W, 152.60' to a #5 Rebar set on the N line of a 16.5' Alley as shown in the plat of Hoge's Subdivsion (P.B. B, Pg. 58);
- 2. N 89°-32'-39" W with the N line of said Alley, 32.00' to a set #5 Rebar;
- 3. N 01°-06'-37" E, 152.60' to a set #5 Rebar;
- 4. \$89°-32'-27" E, 32.57' to the POINT OF BEGINNING.

The above described parcel contains 0.113 acres, more or less, subject to all legal highways and easements of record.

- 1. S 01°-19'-24" W with the W line of said Alley, 146.09' to a #5 Rebar set on the N line of a 16.5' Alley as shown in the plat of Hoge's Subdivision (P.B. B, Pg. 58);
- 2. N 89°-32′-39" W with the N line of said Alley, 123.00' to a set #5 Rebar, passing a set #5 Rebar at 91.00';
- 3. N 01°-06'-37" E, 152.60' to a set #5 Rebar;
- 4. S 89°-32′-27" E, 123.57' to a #5 Rebar set on the W line of a 16.5' Alley as shown in said Bielefeld's Subdivision, passing a set #5 Rebar at 32.57';
- 5. S 01°-19'-24" W with the W line of said Alley, 6.51' to the POINT OF BEGINNING.
