

## Parcel "A" LEGAL DESCRIPTION

Being a part of Parcel #G21-031-004-00 (Prior Deed Referenced in O.R. 687, Pg. 383) and being a part of the SW  $\frac{1}{2}$  of Section 31, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio, more particularly described as follows:

Commencing at an existing Monument Box at the NW corner of the SW ¼ of Section 31; thence S 01°-05'-16" W with the W line of the SW ¼ of Section 31 (centerline of Townline Kossuth Road), 349.22' to a Mag Nail set at the POINT OF BEGINNING; thence the following courses:

- 1. S 89°-32'-26" E, 468.00' to a set #5 Rebar, passing a set #5 Rebar at 72.79';
- 2. N 01°-05'-16" E, 348.93' to a #5 Rebar set on the N line of the SW ¼ of Section 31;
- 3. S 89°-30'-17" E with said fractional section line, 2979.21' to an existing Stone at the NE corner of the SW ¼ of Section 31;
- 4. S 01°-55'-29" W with the E line of the SW ¼ of Section 31, 500.79' to a #5 Rebar set on the N right-of-way line of State Route 33 (Sta. 390+20.63, 654.11' Left);
- 5. N 78°-54'-47" W with the N right-of-way line of State Route 33, 649.62' to a set #5 Rebar (Sta. 384+00, 846.00' Left);

- 9. N 89°-32'-26" W, 468.00' to an existing Mag Nail on the W line of the SW ¼ of Section 31 (centerline of Townline Kossuth Road), passing an existing #5 Rebar at 393.13';
- 10. N 01°-05'-16" E with said fractional section line, 22.00' to the POINT OF BEGINNING.

- 1. Continuing S 89°-11'-43" E, 1557.96' to a #5 Rebar set on the N right-of-way line of State Route 33 (Sta. 381+94.19, 506.15' Left), passing a set #5 Rebar at 778.98';
- 2. S 25°-06'-09" W with the N right-of-way line of State Route 33, 182.36' to a set #5 Rebar (Sta. 380+99.73, 350.16' Left);
- 3. S 53°-17'-17" W with the N right-of-way line of State Route 33, 255.54' to an existing #5 Rebar (Sta. 378+80, 219.00' Left);
