## SCHMIESING SURVEY PT. PARCEL C0901700602 3.328 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 17 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY BENJAMIN SCHMIESING AND JOSEPH McGOVERN (TRUSTEES) AS RECORDED IN OFFICIAL RECORD 655 PAGE 1916 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Commencing at a 1 inch iron pin found in an Auglaize County Engineers Office Monument Box found at the southeast corner of the northeast quarter of Section 17 and being in the centerline of Tri-Township Road;

Thence, with the east line of the northeast quarter of said Section 17 and the center of Tri-Township Road, North 00°58'29" East, 1025.95 feet to an Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with the north line of a 1.069 acre tract of land owned by Harry and Karen Smith as recorded in Official Record 366, Page 673, North 88°33'02" West, 310.41 feet to an iron pin set, passing for reference at 15.00 feet the west right of way line of Tri-Township Road, witnessing at South 89°54'09" West, 4.75 feet an iron pin found;

Thence, with the west line of said 1.069 acres tract, South 00°58'29" West, 150.00 feet to an iron pin set in the north line of a 36.355 acre tract of land owned by Carol Flaute and US Bank NA (Trustees) as recorded in Official Record 586, Page 778;

Thence, with the north line of said 36.355 acre tract, North 88°33'02" West, 215.57 feet to an iron pin set in the east line of a 15.399 acre tract of land owned by Carol Flaute and US Bank NA (Trustees) as recorded in Official Record 586, Page 778;

Thence, with the east line of said 15.399 acre tract of land, North 00°58'29" East, 452.76 feet to an iron pin set in the south line of a 61.533 acre tract of land owned by Yolanda Schmiesing as recorded in Official Record 697, Page 689;

Thence, with the south line of said 61.533 acre tract of land, South 88°33'02" East, 215.57 feet to an iron pin set in the west line of a 1.070 acre tract of land owned by Benjamin Schmiesing and Joseph McGovern (Trustees) as recorded in Official Record 655, Page 1916;

Thence, with the west line of said 1.070 acre tract of land, South 00°58'29" West, 150.20 feet to an iron pin set;

Thence, with the south line of said 1.070 acre tract of land, South 88°33'02" East, 310.41 feet to a Mag Nail set, passing for reference at 290.57 feet and iron pin found and at 295.41 feet the west right of way line of Tri-Township Road;

Thence, with the east line of the northeast quarter of said Section 1 and the centerline of Tri-Township Road, South 00°58'29" West, 152.56 feet to the **True Point of Beginning** containing 3.328 acres more or less of which 0.053 acres lies in the right of way of Tri-Township Road, and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
