


SITUATE IN THE NORTHEAST QUARTER OF SECTION 31 TOWN 5S RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY JAMIE A. CARPENTER ET AL AS RECORDED IN OFFICIAL RECORD 704 PAGE 1485 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a 1 inch iron pin in a monument box found at the southwest corner of the northeast quarter of Section 31 and being in the centerline of Koenig Road;

Thence, with the west line of the northeast quarter of Section 31 and the centerline of Koening Road, North 01°24'40" East, 769.10 feet to a Mag Nail set at the northwest corner of a 1.117 acre tract of land owned by Brittanie M. Williams as recorded in Official Record 703 Page 5239 said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the west line of the northeast quarter of Section 31 and the centerline of Koenig Road, North 01°24'40" East, 559.12 feet to a Mag Nail set at the southwest corner of a 5.000 acre tract of land owned by Kermit L. Hecht as recorded in Official Record 478 Page 1543;

Thence, with the south line of said 5.000 acre tract, a 55.0 acre tract of land owned by Kermit L. Hecht as recorded in Official Record 457 Page 2032 and a 20.277 acre tract of land owned by Christopher M. Schroer & Georgiana E.
