SITUATE IN PART OF LOT 16 OF SURVEY No. 12276 OF THE VIRGINIA MILITARY LANDS AS SUBDIVIDED BY D. HOPKINS, PLAT BOOK 2 PÅGE 74, LOCATED WITHIN GOSHEN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY DONALDSON FARMS, INC. AS RECORDED IN OFFICIAL RECORD 617 PAGE 1815 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an inch iron pin found at the northeast corner of Lot 16 of D. Hopkins Subdivision of Survey No. 12276 of the Virginia Military Lands and being in the centerline of State Route 385;

Thence, with the north line of said Lot 16 and the centerline of State Route 385, North 89°08'44" West, 374.88 feet to a Mag Nail set over stone;

Thence, continuing with the north line of said Lot 16 and the centerline of State Route 385, North 89°06'43" West, 118.06 feet to a Mag Nail set at the northwest corner of a 1.128 acre tract of land owned by Morgan Barnes as recorded in Official Record 617 Page 918, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with the west line of said 1.128 acre tract of land and a new division line, South 00°14'35" East, 270.89 feet to an iron pin set, and passing for reference at 30.01 feet an iron pin with "Kuck & Morrisey" cap found and at 250.00 feet a 5\8 inch iron pin found at the southwest corner of said 1.128 acre tract;

Thence, with new division lines the following 2 courses:

- 1. South 87°19'54" West, 163.39 feet to an iron pin set;
- 2. North 02°57'56" West, 281.61 feet to a Mag Nail set in the north line of said Lot 16 and the centerline of State Route 385, passing for reference at 251.54 feet an iron pin set in the south right of way line of State Route 385;

Thence, with the north line of said Lot 16 and the centerline of State Route 385, South 89°06'43" East, 176.65 feet to the **True Point of Beginning**, containing 1.077 acres more or less of which 0.121 acres lies in the right of way of State Route 385 and with 0.516 acres being from Parcel 2 and 0.561 acres being from Parcel 3 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".

AS RECORDED IN OFFICIAL RECORD 617 PAGE 1815 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an inch iron pin found at the northeast corner of Lot 16 of D. Hopkins Subdivision of Survey No. 12276 of the Virginia Military Lands and being in the centerline of State Route 385;

Thence, with the north line of said Lot 16 and the centerline of State Route 385, North 89°08'44" West, 374.88 feet to a Mag Nail set over stone;

Thence, continuing with the north line of said Lot 16 and the centerline of State Route 385, North 89°06'43" West, 294.71 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described, passing at 118.06 feet a Mag Nail set at the northwest corner of a 1.128 acre tract of land owned by Morgan Barnes as recorded in Official Record 617 Page 918;

Thence, with new division lines the following 3 courses:

- 1. South 02°57'56" East, 281.61 feet to an iron pin set, passing for reference at 30.07 feet an iron pin set in the south right of way line of State Route 385;
- 2. North 87°19'54" East, 163.39 feet to an iron pin set;
- 3. North 00°14'35" West, 20.89 feet to a 5/8 inch iron pin found at the southwest corner of a 1.128 acre tract of land owned by Morgan Barnes as recorded in Official Record 617 Page 918;

Thence, with the south line of said 1.128 acre tract, South 89°06'43" East, 135.08 feet to an iron pin set;

Thence, with new division lines the following 5 courses:

- 1. South 01°08'35" West, 154.82 feet to an iron pin set;
- 2. South 86°12'23" West, 226.89 feet to an iron pin set;
- 3. North 07°48'03" West, 48.71 feet to an iron pin set;
- 4. South 87°43'12" West, 86.14 feet to an iron in set;
- 5. North 12°33'21" West, 390.61 feet to a Mag Nail set in the north line of said Lot 16 and the centerline of State Route 385, passing for reference at 359.76 feet an iron pin set in the south right of way line of State Route 385;

Thence, with the north line of said Lot 16 and the centerline of State Route 385, South 89°06'43" East, 94.33 feet to the **True Point of Beginning** containing 1.497 acres more or less of which 0.063 acres lies within the right of way of State Route 385 and with 0.800 acres being from Parcel 2 and 0.697 acres being from Parcel 3 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
