

## CITY OF ST. MARYS SURVEY DESCRIPTION (TRACT B-1)

Being a part of Parcel Number K3205302002, a 18.597 acre parcel of land situated in St. Marys Township, Auglaize County, Ohio, in the west half of the southwest quarter of Section 2, Township 6 South, Range 4 East, also being part of Out Lot 118 in the City of St. Marys. Being more particularly described as follows:

Commencing for reference at a railroad spike found at the southwest corner of said Section 2 -

Thence, North 00°59'02" East, along the west line of the southwest quarter of the southwest quarter of said Section 2 and the centerline of Beech Street, a distance of 417.42 feet to a point -

Thence, South 89°43'53" East, along the south line of said Out Lot 118, a distance of 322.10 feet to a 5/8 inch iron bar found -

Thence, North 00°58'18" East, a distance of 842.39 feet to a 5/8 inch iron bar found -

Thence, North 00°55'31" East, a distance of 19.43 feet to a 5/8 inch iron bar set. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, North 00°55'31" East, a distance of 236.18 feet to a 5/8 inch iron bar found -

Thence, South 89°43'21" East, a distance of 737.87 feet to a 5/8 inch iron bar found -

Thence, South 00°57'31" West, a distance of 236.18 feet to a 5/8 inch iron bar set -

Thence, North 89°43'21" West, a distance of 737.73 feet to the place of beginning.

Containing 4.000 acres of land more or less.

Subject to all easements and right-of-way of record.
