## CITY OF ST. MARYS PT. PARCEL H 23-035-008-00 TRACT 2 NOB-35-6 DIVISION 25.555 ACRES

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 35 TOWN 5S RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY THE CITY OF ST. MARYS AS RECORDED IN OFFICIAL RECORD 710 PAGE 2432 AND BEING SHOWN AS TRACT 2 OF SURVEY NOB-35-6 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an iron pin with "C.O.E." cap found at the southwest corner of the northeast quarter of Section 35 and the west line of a 0.302 acre tract of land owned by the City of St. Marys as recorded in Official Record 615 Page 1129;

Thence, with the north line of the southeast quarter of Section 35 and the north line of said 0.302 acre tract, South 88°51'34" East, 268.13 feet to an Mag Nail found, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the north line of the southeast quarter of Section 35, South 88°51'34" East, 414.99 feet to a mag nail found in the west line of a 2.181 acres tract of land known as Tract 3 of Survey NOB-35-6 owned by the City of St. Marys as recorded in Official Record 710 Page 2432

Thence, with the west line of said 2.181 acre tract, South 01°08'26" West, 299.32 feet to an iron pin with "Lock Two" cap found, passing for reference at 15.00 feet an iron pin set;

Thence, with the south line of said Tract 3, South 88°44'08" East, 220.85 feet to an iron pin set;

Thence, with a new division line, South 01°02'50" West, 1020.03 feet to an iron pin set in the north right of way line of U.S. Route 33;

Thence, with the north right of way line of U.S. Route 33, North 89°09'13" West, 900.30 feet to an iron pin with "C.O.E." cap found in the west line of the southeast quarter of Section 35 and the east line of a 69.293 acre tract of land owned by The Board of Education Of The City Of St. Marys as recorded in Official Record 565 Page 2299 and the east corporation line of the City of St. Marys;

Thence, with the west line of the southeast quarter of Section 35 and the east line of said 69.293 acre tract and aforesaid corporation line, North 00°54'33" East, 1249.45 feet to an iron pin with "Lock Two" cap found in the south line of a 0.302 acre tract of land owned by the City of St. Marys as recorded in Official Record 615, Page 1129;

Thence, with the south line of said 0.302 acre tract, South 88°51'34" East, 36.47 feet to an iron pin with "Lock Two" cap found;

Thence, with the south line of said 0.302 acre tract, North 76°36'21" East, 239.07 feet to an iron pin "Lock Two" cap found;

Thence, with the east line of said 0.302 acre tract, North 00°54'20" East, 15.00 feet to the **True Point of Beginning** containing 25.555 acres more or less and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
