SITUATE IN THE NORTHWEST QUARTER OF SECTION 5 TOWN 5S RANGE 4E, SALEM TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING ALL OF THOSE LANDS OWNED BY HAROLD W. McCUNE & EMILY J. McCUNE AS RECORDED IN DEED VOLUME 169 PAGE 70 AND PART OF THOSE LANDS OWNED BY HAROLD W. McCUNE & EMILY J. McCUNE AS RECORDED IN DEED VOLUME 253 PAGE 122 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at monument box found at the northwest corner of the northwest quarter of Section 5 and being in the intersection of the centerlines of State Route 197 and Maier – Barber Road;

Thence, with the west line of the northwest quarter of Section 5 and the centerline of State Route 197, South 01°09'29" West, 1792.25 feet to a Mag Nail set at the northwest corner of a 0.83 acre tract of land owned by Harold W. McCune & Emily J. McCune as recorded in Deed Book 169 Page 70, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with the north line of said 0.83 acre tract and a new division line, South 88°46'53" East, 667.14 feet to an iron pin set, passing for reference at 30.00 feet an iron pin set in the east right of way line of State Route 197;

Thence, with a new division line, South 02°06'28" West, 278.59 feet to an iron pin set;

Thence, with a new division line, North 89°53'45" West, 662.63 feet to a Mag Nail set in the west line of the northwest quarter of Section 5 passing for reference at 632.63 feet an iron pin set in the east right of way line of State Route 197;

Thence, with the west line of the northwest quarter of Section 5 and the centerline of State Route 197, North 01°09'29" East, 291.44 feet to the **True Point of Beginning** containing 4.349 acres more or less of which 0.826 acres being out of Deed Book 169 Page 70 and 3.523 acres being out of Deed Book 253 Page 122 with 0.201 acres being in right of way of State Route 197 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
