Surveyor's Description

The following described parcel of land is a part of the Northwest Quarter of Section 35, Duchouquet Township, Town-4-South, Range-6-East, Auglaize County, and in the Village of Cridersville, Ohio, and is a part of a tract of land as evidenced by Deed Volume 34, Page 634, being more particularly described as follows:

Commencing for reference at a point (said point being on the westerly projection of the south line of a 16.50 foot wide alley lying south of Lots 82, 83, and 84 of N. A. Murdock's Addition in said Village of Cridersville, Ohio, and being the northwest corner of said tract of land as evidenced by Deed Volume 34, Page 634;

Thence with a bearing of S. 90°-00'-00" E. along the south line of said 16.50 foot wide alley, same being the north line of said tract of land as evidenced by Deed Volume 34, Page 634, for a distance of 184.00 feet to an Iron Pin (set) and the PLACE OF BEGINNING;

Thence continuing with a bearing of S. 90°-00′-00″ E. along the south line of said 16.50 foot wide alley, same being the north line of said tract of land as evidenced by Deed Volume 34, Page 634, for a distance of 80.00 feet to a 3/4 inch square iron bar (found), said 3/4 inch square bar being 16.50 feet south of the southeast corner of Lot 93 (fraction 14) of the Daniel Phillips Addition to the Village of Cridersville, said 3/4 inch square bar also being situated at the northwest corner of Lot 11 of Allen Spyker's Addition to the Village of Cridersville;

Thence with a bearing of S. 00°-46'-40" W. along the east line of said tract of land as evidenced by Deed Volume 34, Page 634, same being the west line of Lot 11 of said Allen Spyker's Addition, for a distance of 154.26 feet to a mag nail (found) in a concrete walk, and passing through a 3/4 inch square bar (found disturbed) at the southwest corner of said Lot 11 of Allen Spyker's Addition, at a distance of 150.22 feet;

Thence with a bearing of N. 90°-00'-00" W. along the south line of said tract of land as evidenced by Deed Volume 34, Page 634, and along the northerly line of High Street in said Village of Cridersville, for a distance of 80.00 feet to a cross-cut (sawed) in a concrete walk;

Thence with a bearing of N. 00° -46'-40" E. for a distance of 154.26 feet to an iron pin (set) and the original PLACE OF BEGINNING.

The above described parcel of land contains in all 0.2833 Acres of land. The above described tract of land is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

The basis of bearings used for this description were assumed such that the south line of the 16.50 foot wide alley lying south of Lots 82, 83, and 84 of N. A. Murdock's Addition in said Village of Cridersville, Ohio, has a bearing of S. 90°-00'-00" E., consistent with a prior survey performed by James M. Kent PS #6792 (dated December 6, 2000, and drawing #3659) as filed in Survey Book M, Page 209, Auglaize County Engineer's Map Office.
