



SITUATE IN THE NORTHEAST QUARTER OF SECTION 11 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND ALL OF THOSE LANDS OWNED BY WESLEY M. STIENECKER AS RECORDED IN OFFICIAL RECORD 710 PAGE 4637 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at a 1 inch iron pin found in a monument box found at the northwest corner of the northeast quarter of Section 11 and being in the centerline of Lock Two Road, said iron pin also marking the **Point of Beginning** of the tract herein described;

Thence, with the north line of the northeast quarter of Section 11 and the centerline of Lock Two Road, North 89°49'56" East, 66.00 feet to a Mag Nail set at the northwest corner of a 0.680 acre tract of land owned by Steven J. Bushman & Elizabeth A. Bushman as recorded in Official Record 642 Page 2628;

Thence, with the west line of said 0.680 acre tract, South 00°16'22" West, 211.43 feet to an iron pin set in the north line of a 14.815 acre tract of land owned by Crown Control Incorporated as recorded in Official Record 295 Page 138, passing for reference at 20.00 feet an iron pin set in the south right of way line of Lock Two Road;

Thence, with the north line of said 14.815 acre tract, South 89°49'24" West, 66.00 feet to an iron pin with "M.R. Holt" cap found in the east line of a 0.432 acre tract of land owned by D.J. Associates as recorded in Official Record 139 Page 998 and 1001;

Thence, with the east line of said 0.432 acre tract, North 00°16'22" East, 211.44 feet to the **Point of Beginning**, passing for reference at 191.44 feet an iron pin with "M.R. Holt" cap found in the south right of way line of Lock Two Road, containing 0.320 acres more or less of which 0.030 acres lies within the right of way of Lock Two Road and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
