

The following described parcel of land is situated in the southwest quarter of Section 15, Township 6 South, Range 5 East, Washington Township, Auglaize County, Ohio being part of a 77 acre tract as described in O.R. 206, Page 81, also being part of tax parcel No. M3601500300 and is more particularly described as follows:

Commencing at a monument box (found) marking the northeast corner of the southeast quarter of Section 15, also being the intersection of the centerline of Kettlersville Road with the centerline of Burr Oak Road;

thence with the centerline of Burr Oak Road, N 89° 24' 41" W, a distance of 2,648.22 feet to a mag nail (found) over a monument box set by Auglaize County Engineers Department;

thence S 00° 27' 34" W, a distance of 271.58 feet to a 12 inch wood post (found) at the POINT OF BEGINNING for the parcel to be described;

thence continuing S 00° 27' 34" W, a distance of 278.61 feet to the centerline of a ditch, passing at 253.61 feet a 5/8 inch rebar (set);

thence with the centerline of said ditch, N 47° 56' 32" W, a distance of 438.27 feet to a point;

thence continuing with said centerline, N 32° 31' 46" W, a distance of 309.47 feet to a mag nail (set) at the intersection of the centerline of said ditch with the centerline of Burr Oak Road;

thence with the centerline of Burr Oak Road, S 89° 30' 00" E, a distance of 208.56 feet to a mag nail (set);

thence S 00° 08' 46" W, a distance of 226.76 feet to a 1 inch iron pipe (found) passing at 20.00 feet a 1 inch iron pipe (found);

thence N 84° 26' 25" E, a distance of 70.20 feet to a 5/8 inch rebar (set);

thence S 12° 06' 51" E, a distance of 72.83 feet to a 1 inch iron pipe (found);

thence N 85° 08' 21" E, a distance of 201.64 feet to the POINT OF BEGINNING containing 1.799 acres, more or less, subject to all legal highways and easements of record.
