SITUATE IN THE NORTHEAST QUARTER OF SECTION 9 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF OUTLOT 140 OF THE CITY OF ST. MARYS AS OWNED BY ROBIN SOLLMAN AS RECORDED IN OFFICIAL RECORD 667 PAGE 1450 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a stone found at the southeast corner of the northeast quarter of Section 9 and at the intersection of the centerline of Greenville Road and Webb Street;

Thence, with the east line of the northeast quarter of Section 9 and the centerline of Webb Street, North 01°15'46" East, 648.40 feet to the northeast corner of a 9.802 acre tract of land owned by Elm Grove Cemetery as recorded in Deed Volume 138 Page 203;

Thence, with the north line of said 9.802 acre tract, North 89°08'53" West, 25.00 feet to a 5/8 inch iron pin found in the west right of way line of Webb Street and also marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the north line of said 9.802 acre tract of land, North 89°08'53" West, 150.00 feet to an iron pin set at the southeast corner of a 24.85 acre tract of land owned by Charles I. Schwieterman Trust and Lee Ann Schwieterman Trust as recorded in Official Record 602 Page 2281;

Thence, with the east line of said 24.85 acre tract, North 01°15'46" East, 101.75 feet to an iron pin set;

Thence, with a new division line, South 88°46'22" East, 150.00 feet to an iron pin set in the west right of way line of Webb Street;

Thence, with the west right of way line of Webb Street, South 01°15'46" West, 100.76 feet to the **True Point of Beginning** containing 0.349 acres more of less and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in October, 2021 County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
