## SURVEYOR'S DESCRIPTION 1.000 ACRE PARCEL SPLIT (Add-on)

The following described parcel of land is a part of the Northeast Quarter of Section 35, Noble Township, Town-5-South, Range-4-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box situated at the Northeast corner of the Northeast Quarter of said Section 35, Noble Township, Town-5-South, Range-4-East;

Thence with an assumed bearing of S. 89°-32'-18" W. along the North line of the Northeast Quarter of said Section 35, and the legal centerline of Vogel Road (County Road #150), for a distance of 622.34 feet to a Mag Nail (set) and the PLACE OF BEGINNING;

Thence with a bearing of S. 00°-40'-02" E. for a distance of 2,612.46 feet to an Iron Pin (set);

Thence with a bearing of N. 89°-52'-21" W. parallel to and 40.00 feet North of the South line of the East half of the Northeast Quarter of said Section 35, for a distance of 16.68 feet to an Iron Pin (found);

Thence with a bearing of N. 00°-40′-02″ W. for a distance of 2,612.29 feet to a Railroad Spike (found);

Thence with a bearing of N. 89°-32'-18" E. along the North line of the Northeast Quarter of said Section 35, and the legal centerline of Vogel Road (County Road #150), for a distance of 16.68 feet to a Mag Nail (set) and the original PLACE OF BEGINNING.

Containing in all 1.000 Acre of land, of which, 0.008 Acre being previously dedicated for highway purposes. The above described parcel of land is subject to any or all legal easements, reservations, or deed restrictions, if any, upon said premises.

This 1.000 Acre parcel is being split out of permanent parcel #H23-035-010-01. Previous Deed References: Deed Volume OR 463, Page 2175.

The basis of bearings used for this description were assumed from previous surveys of record performed by Gordon Geeslin (PS #5372) per Survey Book L, Page 566, and by James Geeslin (PS #7764) per Survey Book P, Page 303, Auglaize County Engineer's Map Office, whereas the North line of the Northeast Quarter of Section 35, Noble Township, and the legal centerline of Vogel Road (County Road #150) was assumed to have a bearing of S. 89°-32'-18" W.
