Situate in the Southeast Quarter of Section Twenty-three (23), Town Four (4) South, Range Five (5) East, Township of Logan, County of Auglaize, State of Ohio, and being part of a tract conveyed to Jon J. Kriegel (parcel number F1923100500) in Official Record 717, Page 1880 of the Recorder's Office of Auglaize County, Ohio as shown by a survey by Britt R. Havenar, Ohio P.S. No. 8266, and filed in the Auglaize County Engineer's Record of Land Surveys and being more particularly described as follows:

Commencing at an iron pin found in a monument box at the Southeast corner of the Southeast quarter of Section Twenty-three (23), Town Four (4) South, Range Five (5) East, also being on the centerline of right-of-way of Zerkle Road (40' R/W) and the centerline of right-of-way of Bowsher Road (50' R/W) and being the south line of Section Twenty-three (23), said pin being the True Point of Beginning of the tract of land herein described;

Thence North 89 degrees 02 minutes 10 seconds West, along the centerline of right-of-way of Zerkle Road and south section line, a distance of 757.25 feet to a Mag spike set;

Thence North 07 degrees 33 minutes 48 seconds West, a distance of 148.08 feet to a capped iron pin set, passing through a capped iron pin set at a distance of 20.22 feet which marks the north right-of-way line of Zerkle Road;

Thence North 28 degrees 35 minutes 44 seconds West, a distance of 171.94 feet to a capped iron pin set;

Thence North 63 degrees 52 minutes 43 seconds West, a distance of 24.10 feet to a capped iron pin set;

Thence North 00 degrees 00 minutes 39 seconds East, a distance of 128.51 feet to a capped iron pin set;

Thence North 88 degrees 20 minutes 04 seconds West, a distance of 313.69 feet to a capped iron pin set;

Thence South 11 degrees 07 minutes 00 seconds West, a distance of 80.60 feet to a capped iron pin set;

Thence North 00 degrees 32 minutes 54 seconds East, along the north-south half-section line, a distance of 1301.54 feet to a capped iron pin set, passing through a capped iron pin set at a distance of 20.00 feet which marks the north right-of-way line of Zerkle Road;

Thence South 89 degrees 47 minutes 29 seconds East, a distance of 1705.55 feet to a capped iron pin set;

Thence North 00 degrees 50 minutes 43 seconds East, a distance of 944.32 feet to a capped iron pin set;

Thence South 89 degrees 13 minutes 01 seconds East, a distance of 949.01 feet to a Mag spike set, passing through a capped iron pin set at a distance of 924.01 feet which marks the west right-of-way line of Bowsher Road, said spike being on the centerline of right-of-way of Bowsher Road and east line of Section Twenty-three (23);

Thence South 00 degrees 45 minutes 49 seconds West, along said centerline of right-of-way and section line, a distance of 2271.31 feet to an iron pin found in a monument box, said pin being the True Point of Beginning of the above described tract, containing 96.681 acres more or less, subject to all easements of record, of which 2.286 acres are in the present right-of-way.

Kriegel (parcel number F1923100500) in Official Record 717, Page 1880 of the Recorder's Office of Auglaize County, Ohio as shown by a survey by Britt R. Havenar, Ohio P.S. No. 8266, and filed in the Auglaize County Engineer's Record of Land Surveys and being more particularly described as follows:

Commencing at an iron pin found in a monument box at the Southeast corner of the Southeast quarter of Section Twenty-three (23), Town Four (4) South, Range Five (5) East, also being on the centerline of right-of-way of Zerkle Road (40' R/W) and the centerline of right-of-way of Bowsher Road (50' R/W) and being the south line of Section Twenty-three (23), thence North 00 degrees 45 minutes 49 seconds East, along the centerline of right-of-way of Bowsher Road and east section line, a distance of 2271.31 feet to a Mag spike set, said spike being the True Point of Beginning of the tract of land herein described;

Commencing at an iron pin found in a monument box at the Southeast corner of the Southeast quarter of Section Twenty-three (23), Town Four (4) South, Range Five (5) East, also being on the centerline of right-of-way of Zerkle Road (40' R/W) and the centerline of right-of-way of Bowsher Road (50' R/W) and being the south line of Section Twenty-three (23), thence North 89 degrees 02 minutes 10 seconds West, along the centerline of right-of-way of Zerkle Road and south section line, a distance of 757.25 feet to a Mag spike set, said spike being the True Point of Beginning of the tract of land herein described;
