

PARCEL 1 LEGAL DESCRIPTION

Being Part of Parcel #I24-221-001-03 as described in OR Volume 713, Page 5253 of the Auglaize County Official Record of Deeds. Situated in the SW ¼ of Section 22, T-6-S, R-6-E, Pusheta Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing for reference at a 1 inch iron pin in a monument box found at the southeast corner of said SW ¼ of Section 22, also being on the centerline of Santa Fe-New Knoxville Road (CR 100);

Thence along the south line of said SW ¼ of Section 22, also being the centerline of Santa Fe-New Knoxville Road (CR 100), N 86°-55'-00" W (basis of bearing) a distance of 1,219.70 feet to a set mag nail at the intersection of the centerlines of said Santa Fe-New Knoxville Road and Rupert Road (TR 163);

Thence along said centerline of Rupert Road (TR 163), N 26°-46'-37" E a distance of 554.23 feet to a set mag nail marking the southwest corner of a 2.612 acre tract of land as described in OR Volume 713, Page 5253 of the Auglaize County Official Record of Deeds, being the POINT OF BEGINNING for the tract of land herein described:

Commencing for reference at a 1 inch iron pin in a monument box found at the southeast corner of said SW ¼ of Section 22, also being on the centerline of Santa Fe-New Knoxville Road (CR 100);

Thence along the south line of said SW ¼ of Section 22, also being the centerline of Santa Fe-New Knoxville Road (CR 100), N 86°-55'-00" W (basis of bearing) a distance of 1,219.70 feet to a set mag nail at the intersection of the centerlines of said Santa Fe-New Knoxville Road and Rupert Road (TR 163);
