

Parcel "B" LEGAL DESCRIPTION

Being a part of Parcel #N41-016-011-03 and being a part of the NE ¼ of Section 16, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio (Prior Deed Referenced in O.R. 712, Pg. 3538), more particularly described as follows:

Commencing at an existing Monument Box at the NW corner of the NE ¼ of Section 16; thence S 89°-40'-06" E with the N line of the NE ¼ of Section 16 (centerline of Fairmount Road), 60.00' to an existing Mag Nail; thence S 01°-06'-16" W, 1362.95' to an existing #5 Rebar at the POINT OF BEGINNING; thence the following courses:

- 1. S 88°-54'-28" E, 617.39' to an existing #5 Rebar;
- 2. S 01°-06′-16" W, 200.00' to a set #5 Rebar;
- 3. N 88°-54′-28" W, 617.39' to a set #5 Rebar;
- 4. N 01°-06'-16" E, 200.00' to the POINT OF BEGINNING.

The above described parcel contains 2.835 acres, more or less, subject to all legal highways and easements of record.

Parcel "A + B" LEGAL DESCRIPTION

Being all of Parcel #N41-016-011-01 & a part of Parcel # N41-016-011-03 and being a part of the NE ¼ of Section 16, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio (Prior Deeds Referenced in O.R. 712, Pg. 3532 & O.R. 712, Pg. 3538), more particularly described as follows:

Commencing at an existing Monument Box at the NW corner of the NE ¼ of Section 16; thence S 89°-40′-06″ E with the N line of the NE ¼ of Section 16 (centerline of Fairmount Road), 60.00′ to an existing Mag Nail at the POINT OF BEGINNING; thence the following courses:

- 1. Continuing S 89°-40'-06" E with the N line of the NE ¼ of Section 16 (centerline of Fairmount Road), 287.45' to an existing Mag Nail;
- 2. S 01°-06'-16" W, 410.72' to an existing #5 Rebar, passing a set #5 Rebar at 25.00';
- 3. S 89°-40′-06" E, 330.00′ an existing #5 Rebar;
- 4. S 01°-06'-16" W, 1160.42' to a set #5 Rebar;
- 5. N 88°-54'-28" W, 617.39' to a set #5 Rebar;
- 6. N 01°-06'-16" E, 1562.95' to the POINT OF BEGINNING, passing an existing #5 Rebar at 200.00' and 1537.95'.
