

DONALD & PAULA REESE SURVEY 3.046 ACRE TRACT

The following described tract of land is part of the Northeast Quarter of Section 16, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio, being part of Parcel No. I25-016-010-00 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Northwest corner of the Northeast Quarter of Section 16, Pusheta Township and in the centerline of Township Road 120 (Pusheta Road;

Thence S.89°05'46"E. along the North line of the Northeast Quarter of said Section 16 and along the centerline of Township Road 120, a distance of 524.65 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°05'46"E. along the above described line, a distance of 464.00 feet to a Mag Nail (set);

Thence S.00°32'27"W. a distance of 286.00 feet to a 5/8-inch iron pin (set), passing thru a 5/8-inch iron pin (set) for reference at 57.49 feet in the South L.A. I-75 right-of-way line;

Thence N.89°05'46"W., parallel to the North line of the Northeast Quarter of Section 16 and the centerline of Township Road 120, a distance of 464.00 feet to a 5/8-inch iron pin (set);

Thence N.00°32'27"E. a distance of 286.00 feet to the Mag Nail (set), passing thru a 5/8-inch iron pin (set) for reference at 266.00 feet in the South right-of-way line of Township Road 120, said Mag Nail (set) was the true PLACE OF BEGINNING.

Containing in all 3.046 Acres of which 0.331 Acre has been used for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 147, Page 129. This plat is recorded in Survey Book "U", Page 948, in the Auglaize County Engineer's Office. Basis for bearings for this tract is holding the centerline of Township Road 120 (Pusheta Road) and the North line of the Northeast Quarter of Section 16, Pusheta Township as S.89°05'46"E. from the Ohio State Plane-North Coordinate System NAD83 (2011).
